## A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 304A-2007, Hawaii Revised Statutes, is
2	amended b	y amending subsection (b) to read as follows:
3	"(b)	The report shall [ <del>also</del> ] include [ <del>all</del> ]:
4	(1)	All expenditures in excess of each fund's
5		appropriation for each fiscal year [-] ; and
6	(2)	For each fund, listed by program identification
7		number, that has an unencumbered cash balance of
8		\$1,000,000 or more or a cash deficit of \$1,000,000 or
9		more at the end of the previous fiscal year, where
10		that balance or deficit is greater than twenty-five
11		per cent of the previous fiscal year's expenditures,
12		the estimated:
13		(A) Expenses for the current fiscal year;
14		(B) Revenues for the current fiscal year; and
15		(C) Unencumbered cash balance or cash deficit at the
16		end of the current fiscal year."
