A BILL FOR AN ACT

RELATING TO PROCUREMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 103B-3, Hawaii Revised Statutes, is
 amended as follows:

3 1. By amending subsection (a) to read:

4 "(a) A contractor awarded any contract shall ensure that
5 Hawaii residents compose not less than eighty per cent of the
6 workforce employed to perform the contract on a particular
7 construction project, as determined under subsection (b). Prior
8 to an award of a contract, the contractor may withdraw a bid
9 without penalty if the contractor finds that it is unable to
10 comply with this subsection."

11 2. By amending subsections (c) and (d) to read:

12 "(c) [Every contractor shall comply with this chapter for 13 the entire duration of the contract.] Certification of 14 compliance with this chapter shall be made under oath by an 15 officer of the general contractor and applicable subcontractor 16 to the procurement officer [on-a monthly basis.] with the notice 17 of completion of the contract.

5	matured, penalties that were incurred, and proceedings that were
6	begun before its effective date.
7	SECTION 3. Statutory material to be repealed is bracketed
8	and stricken. New statutory material is underscored.
9	SECTION 4. This Act shall take effect on July 1, 2011.
