A BILL FOR AN ACT

RELATING TO THE DEPARTMENT OF THE ATTORNEY GENERAL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. In November 2011, Honolulu will host the Asia-Pacific Economic Cooperation (APEC) Leaders Meeting. APEC is 2 the premier forum for Asia-Pacific economies to discuss trade 3 and investment issues. The President of the United States, 4 heads of state, cabinet ministers, business leaders, government 5 officials, and many others are expected to attend the APEC 6 meeting. 7 It is imperative that the State of Hawaii provide a safe 8 9 venue for the APEC meeting. The funding requested in this Act will support the department of the attorney general's efforts in 10 planning for the event and provide funding for law enforcement 11 personnel and their related operating and equipment costs, and 12 13 computers and software, to ensure a successful and safe APEC 14 meeting. SECTION 2. There is appropriated out of the general 15 16 revenues of the State of Hawaii the sum of \$ _____, or so much thereof as may be necessary for fiscal year 2011-2012, to 17 18 carry out the purposes of this Act, including operating expenses
