## A BILL FOR AN ACT

RELATING TO TRANSPORTATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature hereby finds and declares that: 2 The United States Congress has authorized states under (1)the federal National Highway System Designation Act of 1995 and 3 the federal Safe, Accountable, Flexible, Efficient 4 5 Transportation Equity Act: A Legacy for Users (Public Law 109-59) to issue "GARVEE Bonds," which are tax-exempt revenue 6 anticipation notes or bonds backed by annual federal 7 8 appropriations for federal-aid highway program transportation projects. 9

10 (2) Utilizing revenue anticipation notes and bonds to
11 finance federal transportation projects can greatly accelerate
12 projects and can result in significant cost savings to the
13 State, since those transportation projects can be completed at
14 present-day costs.

(3) Funding transportation projects with revenue
anticipation notes or bonds can also deliver projects to the
public significantly sooner than traditional funding mechanisms.

1 (4) Therefore, it is in the best interest of the State of 2 Hawaii to develop these new and innovative methods for funding and accelerating critical transportation infrastructure 3 projects. 4 5 SECTION 2. Chapter 264, Hawaii Revised Statutes, is amended by adding a new part to be appropriately designated and 6 7 to read as follows: "PART FEDERAL HIGHWAY REVENUE 8 9 ANTICIPATION NOTES AND BONDS § 264- Definitions. Whenever used in this part, unless a 10 different meaning clearly appears from the context: 11 "Department" means the department of transportation. 12 13 "Director" means the director of transportation. "Federal transportation funds" means any funds apportioned 14 to the state by the United States Department of Transportation, 15 including, but not limited to, funds paid pursuant to the Safe, 16 17 Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (Public Law 109-59) and any successor federal-18 aid highway program authorization act or acts, and includes 19 federal reimbursements and grants with respect to gualified 20 21 federal-aid highway program transportation projects.

(a) The director may from time to time 4 5 select and designate qualified federal-aid highway program transportation projects to be funded from the proceeds of notes, 6 if financing of the project from the proceeds of notes has been 7 8 approved by the federal highway administration and the regional transportation planning agency, and the project has completed 9 10 environmental clearance and project design, and shall submit the list of such projects, together with the anticipated cost 11 12 thereof, to the legislature as part of the department's annual 13 budget, together with the request that the legislature authorize the issuance of notes and appropriate the proceeds thereof to 14 such projects in accordance with part III of chapter 39. 15

On or before April 1 of each year, the department, in 16 (b) conjunction with the department of budget and finance, shall 17 prepare an annual analysis of the bonding capacity of federal 18 transportation funds deposited in the state highway fund. 19 · 20 (c) The department shall establish guidelines for eligibility for funding allocations under this part. The 21 quidelines shall be nondiscriminatory and shall be designed to 22

allow as many counties as possible to establish eligibility for
 funding allocations under this part, regardless of the
 population or geographic location of the county.

§ 264- Issuance of revenue anticipation notes. 4 The (a) department, in order to provide for the financing of selected 5 qualified federal-aid highway program transportation projects, 6 7 may issue revenue anticipation notes. The payment of the principal of, premium, if any, and interest on such revenue 8 anticipation notes shall be secured by a pledge of future 9 receipts of federal transportation funds, in accordance with 10 11 part III of chapter 39, relating to revenue bonds. Revenue anticipation notes are hereby determined to be revenue bonds, 12 and receipts of federal transportation funds are hereby 13 determined to be revenues within the meaning of part III of 14 15 chapter 39. The department:

16 (1) Shall comply with title 23, section 122, United States
17 Code, when issuing revenue anticipation notes under
18 this part;

19 (2) May issue tax-exempt or taxable revenue anticipation

Each report shall compile and detail (1) the total 2 amount of outstanding revenue anticipation notes issued pursuant 3 4 to this part; (2) the qualified federal-aid highway program transportation projects funded by those outstanding revenue 5 anticipation notes; (3) the amount of note proceeds expended on 6 each project; (4) the status of each project; (5) the estimated 7 8 date of completion for such projects not yet completed; (6) the total amount of federal transportation funds paid to the 9 10 department since such revenue anticipation notes have been 11 issued; and (7) the total amount of proceeds from the issuance 12 of revenue anticipation notes, state matching funds and federal transportation funds applied by the department in each state 13 fiscal year for the payment of such revenue anticipation notes 14 and the costs associated with the issuance and administration of 15 such notes." 16

SECTION 3. Section 39-51, Hawaii Revised Statutes, is amended by amending the definitions of "revenue" and "revenue bonds" to read as follows:

20 ""Revenue" means the moneys collected, including any moneys 21 collected from the State or any department, or any county or 22 board, agency or instrumentality thereof, from the rates,

rentals, fees, and charges prescribed for the use and services 1 of, and the facilities and commodities furnished by, an 2 undertaking or the use and services and benefits of a loan 3 4 program; provided that the term shall include all insurance premium payments, assessments, surcharges, investment earnings 5 and all other income of the Hawaii hurricane relief fund [-], and 6 all reimbursements and grants received from the federal United 7 8 States Department of Transportation with respect to federal-aid highway program transportation projects. 9

10 "Revenue bonds" means all bonds payable solely from and secured by the revenue, or user taxes, or any combination of 11 12 both, of an undertaking or loan program or any loan made thereunder for which bonds are issued and as otherwise provided 13 in this part; provided that the term shall include all bonds 14 issued by the director of finance under the authority of 15 section 10(a), Act 339, Session Laws of Hawaii 1993, as amended, 16 for the purposes of the hurricane bond loan fund [-,], and all 17 revenue anticipation notes or bonds issued by the director of 18 transportation under authority of section , Act , 19 20 Session Laws of Hawaii , as amended, for the purposes of the transportation financing account of the highway special 21 fund." 22

#### JUSTIFICATION SHEET

DEPARTMENT: Budget and Finance

TITLE: A BILL FOR AN ACT RELATING TO TRANSPORTATION.

PURPOSE: The purpose of the bill is to provide for the issuance of grant revenue anticipation revenue notes and bonds or "GARVEE Bonds," as provided for by the federal National Highway System Designation Act of 1995 (the "NHS Act") and the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users ("SAFETEA-LU") for legislatively appropriated transportation projects in the State. The federal GARVEE program permits states to leverage annual federal appropriations for federal-aid highway program transportation projects, with the result that the State may accelerate the construction and delivery of transportation projects, resulting in cost savings to the State and the greater convenience to the general public of having projects available for use earlier than would otherwise be the case. The bill provides that the federal-aid highway program reimbursements and grants are "revenues" within the meaning of part III, chapter 39, Hawaii Revised Statutes. The bill also creates a Transportation Financing Account in the Highway Special Fund for the purpose of receiving and disbursing federalaid grants and the proceeds of the "GARVEE Bonds."

MEANS:

Add a new Part to Chapter 264 and amend section 39-51, Hawaii Revised Statutes.

JUSTIFICATION: The program arises out of the need to improve, rehabilitate, and renovate the State's transportation facilities. This need increases while federal, state, and local financial resources are constant or declining. State and local sources of transportation funding have not kept pace with the need for infrastructure. The issuance of GARVEE Bonds will improve the transportation infrastructure in the State by leveraging future receipts of federal-aid highway program reimbursements and grants to permit the construction of transportation projects earlier and at a lower cost to the State than would otherwise be possible.

> The Department of Transportation, Highways Division needs enabling legislation to establish and implement a GARVEE bond program to take advantage of the federal program authorized by the NHS Act and SAFETEA-LU.

### Impact on the public:

The proposed bill is meant to provide the traveling public a safe and efficient transportation system through the optimal use of existing and additional financial resources.

### Impact on the department and other agencies:

The proposed bill is meant to provide a mechanism to significantly and permanently increase financing capacity for the transportation projects.
