TITLE: A BILL FOR AN ACT RELATING TO HEALTH INSURANCE.

PURPOSE: To authorize the insurance commissioner to enforce applicable federal law regarding an accident and health or sickness insurer, a mutual benefit society, and a health maintenance organization.

MEANS: Add new sections to chapters 431, 432, and 432D, Hawaii Revised Statutes.

This bill amends chapter 431:10A regarding accident and health or sickness insurers; chapter 432 regarding mutual benefit societies; and chapter 432D regarding health maintenance organizations.

JUSTIFICATION: Enabling legislation is necessary to comply with the provisions of the Patient Protection and Affordability Act of 2010, as amended, requiring state enforcement of health insurance reform.

> <u>Impact on the public:</u> This bill will establish the commissioner's dual authority with the federal government to enforce health insurance reform.
