A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Act 51, Session Laws of Hawaii 2004, as amended 2 by Act 221, Session Laws of Hawaii 2004, required the 3 implementation of a new allocation method, the weighted student formula, to distribute funds to schools based on the 4 5 characteristics of the students. Act 51, as amended, also 6 created the committee on weights whose responsibility is to 7 recommend a formula and various weights of characteristics to the board of education. With six years of experience, it has 8 9 become apparent that, to provide stability and predictability 10 for the principals and the school community councils, an improved practice would be to have the committee on weights meet 11 every odd-numbered year rather than each year. Schools that are 12 developing academic and financial plans to improve student 13 achievement need to be assured of constant funding over a 14 two-year period. 15

16 The purpose of this Act is to provide that the17 committee on weights will meet every odd-numbered year.

Based upon 6 7 recommendations from the committee on weights, the board of 8 education, not less than [annually,] biennially, shall adopt a weighted student formula for the allocation of moneys to public 9 schools that takes into account the educational needs of each 10 11 student. The department, upon the receipt of appropriated moneys, shall use the weighted student formula to allocate funds 12 to public schools. Principals shall expend moneys provided to 13 the principals' schools. This section shall only apply to 14 15 charter schools for fiscal years in which the charter schools elect pursuant to section 302B-13 to receive allocations 16 according to the weighted student formula." 17 18 SECTION 4. Statutory material to be repealed is bracketed 19 and stricken. New statutory material is underscored. SECTION 5. This Act shall take effect on July 1, 2011. 20 21

JUSTIFICATION SHEET

DEPARTMENT: Education TITLE: A BILL FOR AN ACT RELATING TO EDUCATION. PURPOSE: To provide more time for the collection and analysis of data regarding the weighted student formula (WSF). In addition, to provide school communities with a more predictable funding basis from which to plan and implement school operations. MEANS: By amending section 302A-1303.5(a) and 1303.6, Hawaii Revised Statutes. JUSTIFICATION: Act 51, Session Laws of Hawaii 2004, established the Committee on Weights (COW) and tasked it with the responsibility to meet annually to adopt the WSF. The COW has fulfilled its task of annually re-evaluating the WSF and presenting its collective recommendation to the Board of Education. Now that the WSF and the schools' Academic and Financial Planning processes has been well established with five years of implementation and six years of planning, the need to revisit the WSF on an annual basis has diminished. In addition, the investment of time by Committee members and other Department staff in supporting the annual re-evaluation of the WSF has been considerable. The Committee has been made up of school community members, including: teachers, principals, classified staff, and community members. Amending the existing requirement to requiring the COW to meet biennially would not preclude the Committee from convening if the need to consider amendments to the WSF should arise.
