A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The recent implementation of the common core 2 state standards initiative led by the National Governors Association Center for Best Practices and the Council of Chief 3 State School Officers, has resulted in a set of common core 4 5 state standards in English language arts and mathematics that 6 have been developed by teachers, school administrators, and 7 experts to provide a clear and consistent framework to prepare students for college and the workforce. These standards define 8 the knowledge and skills students should possess within their K-9 12 education careers so that they will graduate high school able 10 to succeed in entry-level, credit-bearing academic college 11 12 courses and in workforce training programs. Therefore, the 13 administration of nationally norm-referenced tests is no longer 14 necessary.

15 The purpose of this Act is to repeal the inclusion of a 16 norm-reference reading and mathematics tests in grades 3 through 17 8 and one high school grade in the statewide assessment program. 18 The board of education has adopted the common core state

standards and Hawaii is a governing member of the SMARTER
 Balanced Assessment Consortium that will be developing and
 implementing a summative assessment in grades 3 through 8 and
 high school in English language arts and mathematics that will
 provide comparable achievement standards across all of the
 states that are members of the Consortium.

7 SECTION 2. Section 302A-201, Hawaii Revised Statutes, is
8 amended to read as follows:

"§302A-201 Statewide performance standards. [-(a)] 9 The 10 board shall establish statewide performance standards and the means to assess the standards based upon the recommendations in 11 the final report of the performance standards commission 12 established pursuant to Act 334, Session Laws of Hawaii 1991; 13 14 provided that the board may review and modify the performance standards, as the board deems necessary, to reflect the needs of 15 public school students and educational goals adopted by the 16 board. 17

18 [(b) Notwithstanding any law-to-the contrary, the 19 department-shall establish-procedures and guidelines for, and 20 shall-expand, its statewide assessment program to include norm-21 referenced testing in the same grades as required by the federal 22 No Child Left Behind Act-of 2001 (Public Law 107-110) standards-

JUSTIFICATION SHEET

DEPARTMENT: Education

TITLE: A BILL FOR AN ACT RELATING TO EDUCATION.

PURPOSE: To repeal the administration of nationally normed reference test.

MEANS: Amend section 302A-201, Hawaii Revised Statutes.

JUSTIFICATION: The Department of Education annually administers the Hawaii State Assessment (HSA); a criterion reference test (CRT), in reading and mathematics in grades 3 through 8 and 10, and in science in grades 4, 8, and 10, as required under No Child Left Behind (NCLB). The HSA assesses all Hawaii Content and Performance Standards (HCPS III) and related benchmarks that represent what Hawaii students should know and demonstrate at the conclusion of the specified grade level for a content area.

> The Common Core State Standards Initiative is a state-led effort coordinated by the National Governors Association Center for Best Practices and the Council of Chief State School Officers. The standards were developed in collaboration with teaches, school administrators, and experts, to provide a clear and consistent framework to prepare students for college and the work force. Since Hawaii is a part of the Common Core State Standards Initiative and a governing state in the SMARTER Balanced Assessment Consortium, the Department is fully committed to adopting and implementing statewide, the Consortium's summative assessments in grades 3-8 and high school, for both English language arts and mathematics. Consistent with the Consortium's commitment to comparable and rigorous assessments, the Consortium will determine common performance level descriptors and achievement standards.
