A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for 1 immediate passage in accordance with section 9 of article VII of 2 the Constitution of the State of Hawaii. 3 SECTION 2. The purpose of this Act is to amend Act 191, 4 Session Laws of Hawaii 2010, which appropriated moneys from the 5 emergency and budget reserve fund to maintain the levels of 6 programs determined to be essential to education, public health, 7 and public welfare for fiscal year 2010-2011. 8 The existing language of certain of Act 191's 9 appropriations makes it difficult to carry out the legislature's 10 intention of awarding moneys to specific organizations. This 11 12 Act provides technical corrections to Act 191 to permit the awarding of moneys to specified organizations and extends the 13 lapse date of Act 191's appropriations from June 30, 2011 to 14 June 30, 2012. 15

SECTION 3. Act 191, Session Laws of Hawaii 2010, is
amended by amending sections 12, 16, 18, 19, 21, 22, 30, 32, 33,
34, 35, 36, 38, 39 to read as follows:

. 1	"SECTION 12. There is appropriated out of the emergency
2	and budget reserve fund of the State of Hawaii the sum of
3	\$332,000 or so much thereof as may be necessary for fiscal year
4	2010-2011 for the Waianae District Comprehensive Health and
5	Hospital Board, Incorporated to support its emergency room
6	services. This is a grant pursuant to chapter 42F, Hawaii
7	Revised Statutes.
8	The sum appropriated shall be expended by the department of
9	health for the purposes of this Act.
10	SECTION 16. There is appropriated out of the emergency and
11	budget reserve fund of the State of Hawaii the sum of \$500,000
12	or so much thereof as may be necessary for fiscal year 2010-2011
13	for Kokua Kalihi Valley Comprehensive Family Services. <u>This is</u>
14	a grant pursuant to chapter 42F, Hawaii Revised Statutes.
15	The sum appropriated shall be expended by the department of
16	health for the purposes of this Act.
17	SECTION 18. There is appropriated out of the emergency and
18	budget reserve fund of the State of Hawaii the sum of \$200,000
19	or so much thereof as may be necessary for fiscal year 2010-2011
20	for the Windward Spouse Abuse Shelter. This is a grant pursuant
21	to chapter 42F, Hawaii Revised Statutes.

services. This is a grant pursuant to chapter 42F, Hawaii
Revised Statutes.
The sum appropriated shall be expended by the department of

for Volunteer Legal Services Hawaii to provide pro bono legal 1 services for indigent persons. This is a grant pursuant to 2 chapter 42F, Hawaii Revised Statutes. 3 4 The sum appropriated shall be expended by the judiciary for 5 the purposes of this Act. SECTION 33. There is appropriated out of the emergency and 6 7 budget reserve fund of the State of Hawaii the sum of \$720,000 or so much thereof as may be necessary for fiscal year 2010-2011 8 for the Legal Aid Society of Hawaii to provide general civil 9 legal services. This is a grant pursuant to chapter 42F, Hawaii 10 11 Revised Statutes. The sum appropriated shall be expended by the judiciary for 12 the purposes of this Act. 13 SECTION 34. There is appropriated out of the emergency and 14 budget reserve fund of the State of Hawaii the sum of \$282,000 15 or so much thereof as may be necessary for fiscal year 2010-2011 16 for the Hawaii Family Law Clinic to provide services to obtain 17 temporary restraining orders. This is a grant pursuant to 18 chapter 42F, Hawaii Revised Statutes. 19 The sum appropriated shall be expended by the judiciary for 20 the purposes of this Act. 21

TITLE: A BILL FOR AN ACT RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

PURPOSE: To amend Act 191, Session Laws of Hawaii 2010 to permit the awarding of moneys to specified organizations.

MEANS: Amends Act 191, Session Laws of Hawaii 2010, adding in language specifying Chapter 42F grants and extending the lapse date of appropriations made in Act 191, SLH 2010 to June 30, 2012.

JUSTIFICATION: The 2010 Regular Session of the Legislature appropriated funds from the emergency and budget reserve fund. This measure would clarify that these appropriations are grants pursuant to Chapter 42F, which will allow the awarding of money to those organizations specified in the original Act.

> Impact on the public: The various organizations will be able to receive their funding in a timely manner. As these organizations provide services to the public, this funding will assist those most in need.
