If such-person demonstrates sufficient improvement or 11 progress, or for other good reason, the family court may order 12 the person's return to a youth correctional facility."] 13 SECTION 2. Description:

Repeal section 352-28, Hawaii Revised Statutes, which authorizes the executive director of the office of youth services, with the approval of the family court, to transfer a committed youth from the Hawaii Youth Correctional Facility to an adult correctional facility for disciplinary or other reasons.

JUSTIFICATION SHEET

TITLE:

A BILL FOR AN ACT RELATING TO THE TRANSFER OF YOUTH TO AN ADULT CORRECTIONAL FACILITY.

PURPOSE:

To repeal the authority of the Office of Youth Services (OYS) Executive Director to transfer youth, with the approval of the family court, to an adult correctional facility for disciplinary or other reasons.

MEANS:

Repeal section 352-28, Hawaii Revised Statutes.

JUSTIFICATION:

The proposed bill will ensure that youth committed to the Hawaii Youth Correctional Facility will not be transferred to adult correctional facilities for disciplinary reasons where they would be exposed to serious adult offenders and subjected to possible physical, mental, and sexual assault.

In addition, the proposed bill will simplify the State of Hawaii's efforts to comply with the federal Juvenile Justice Delinquency Prevention Act (JJDPA) which requires "sight and sound" separation between juvenile and adult offenders. Violation of this requirement would jeopardize future federal funding.

Public Safety would not be required to assume
the responsibility of housing juveniles
committed to the Office of Youth Services.
