1 (2) One member shall be a person possessing membership in 2 an environmental organization organized in the State; One member shall be a person possessing membership in a 3 (3) 4 land conservation organization organized in the State; One member shall be a person possessing membership in a 5 (4) 6 statewide agricultural association; and (5) One member shall be a person knowledgeable about native 7 Hawaiian culture. 8 9 The chairperson of the natural area reserves system commission, 10 or the chairperson's designated representative from the natural 11 area reserves system commission, shall serve as an ex officio voting member [and the chairperson of the commission]. 12 The members of the commission shall elect the chairperson of the 13 14 commission. The members of the commission shall receive no compensation for their services on the commission but shall be 15 16 entitled to reimbursement for necessary expenses, including travel expenses, incurred in the discharge of their duties." 17 18 SECTION 3. Statutory material to be repealed is bracketed 19 and stricken. New statutory material is underscored. 20 21

JUSTIFICATION:

Section 173A-2.4(a), HRS, presently mandates that the Chairperson of NARS Commission serve as an ex-officio voting member and Chairperson of the LLC Commission. Service on state boards and commissions is unpaid, involving heavy time commitment and workload on the part of their members, especially those members who serve as chairpersons and, as such, take on an even bigger workload.

Authorizing the Chairperson of the NARS Commission to designate a representative from the NARS Commission to serve on the LLC Commission and removing the requirement that the NARS Commission Chairperson serve as the LLC Commission Chairperson will ease the workload of this member.
