A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the composition of a
- 2 panel that nominates the members of the paroling authority
- 3 should be updated. One of the panel delegates, Hawaii Criminal
- 4 Justice Association, is no longer in existence.
- 5 The purpose of this Act is to update the composition of the
- 6 panel that nominates the members of the paroling authority.
- 7 SECTION 2. Section 353-61, Hawaii Revised Statutes, is
- 8 amended to read as follows:
- 9 "§353-61 Hawaii paroling authority; appointment; tenure;
- 10 qualifications. Members of the paroling authority shall be
- 11 nominated by a panel composed of the chief justice of the Hawaii
- 12 supreme court, the director, [the president of the Hawaii
- 13 Criminal Justice Association] the president of the bar
- 14 association of Hawaii, a representative designated by the head
- 15 of the Interfaith Alliance Hawaii, a member from the general
- 16 public to be appointed by the governor, and the president of the
- 17 Hawaii chapter of the National Association of Social Workers.

- 1 The panel shall submit to the governor the names of not less
- 2 than three persons designated as the nominees, for chairperson
- 3 or as a member, for each vacancy. The requirement for
- 4 nomination by the panel established under this section shall
- 5 only apply to a nominee's nomination by the governor to an
- 6 initial term on the paroling authority and not to any subsequent
- 7 consecutive term of a sitting paroling authority member or
- 8 chairperson whose initial appointment to office was made
- 9 pursuant to a nomination by the panel. The governor shall
- 10 appoint, in manner prescribed by section 26-34, a paroling
- 11 authority to be known as the Hawaii paroling authority, to
- 12 consist of three members one of whom shall be designated
- 13 chairperson. Appointments shall be made for terms of four
- 14 years, commencing from the date of expiration of the last
- 15 preceding term. Any vacancy in an unexpired term shall be
- 16 filled by appointment for the reminder of the unexpired term.
- 17 Nominees to the authority shall be selected on the basis of
- 18 their qualifications to make decisions that will be compatible
- 19 with the welfare of the community and of individual offenders,
- 20 including their background and ability for appraisal of
- 21 offenders and the circumstances under which offenses were
- 22 committed."

Description:

This measure amends section 353-61, Hawaii Revised Statutes, to delete the Hawaii Criminal Justice Association from the panel to nominate members of the paroling authority since the association no longer exists.

PURPOSE:

This bill amends the membership of the Hawaii Paroling nominating panel to delete a panel member who is a delegate from an organization that no longer exists.

MEANS:

Amend section 353-61, Hawaii Revised

Statutes.

JUSTIFICATION:

The existing statute specifies the members of a panel to nominate the members of the paroling authority. The president of the Hawaii Criminal Justice Association is one of the named members on this panel.

However, the Hawaii Criminal Justice Association has not been a functional organization for over seven years, and there is no membership or president at this time. Therefore, the position of president of this organization should not be named to the panel to nominate members to the paroling authority.

Impact on the public: This initiative will provide for the better operation and selection of members of the paroling authority.

Impact on the department and other agencies: This measure clarifies the panel to nominate members to the paroling authority, and therefore will provide for the better operation of the agency and government as a whole.
