A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE REGISTRATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-2, Hawaii Revised Statutes, is 2 amended by adding a new definition to be appropriately inserted and to read as follows: 3 ""After market motorcycle frame" means a frame that is 4 5 manufactured to replace the frame of a motorcycle that was 6 certified by its manufacturer to be in compliance with all 7 applicable Federal Motor Vehicle Safety Standards as of the date of manufacture, or the frame of a homemade motorcycle that was 8 9 manufactured not for profit by a person who built the motorcycle as a hobby." 10 SECTION 2. Section 286-42, Hawaii Revised Statutes, is 11 amended by amending subsection (a) to read as follows: 12 The county director of finance shall examine and to "(a) 13 the best of the director's ability determine the genuineness and 14 regularity of every registration and transfer of registration of 15 a vehicle as in this part provided, in order that every 16 certificate issued for a vehicle shall contain true statements 17 of the ownership thereof, and to prevent the registration of a 18

1 vehicle by any person not entitled thereto, and the director of finance may require any applicant to furnish such information, 2 in addition to that contained in the application, as may be 3 necessary to satisfy the director of finance of the truth and 4 regularity of the application. The director of finance may 5 6 accept any county certificate of title issued for a vehicle as 7 prima facie evidence of ownership for registration and transfer 8 of registration. The director may issue vehicle identification numbers for reconstructed vehicles, special interest vehicles, 9 or motorcycles, which do not have vehicle identification numbers 10 11 if the director determines that the requirements of this section have been met. 12

The county director of finance may register a motorcycle 13 14 with an after market motorcycle frame, using the [vehicle identification] number of the frame as issued by the [incomplete 15 vehicle] manufacturer of the frame[-], the vehicle 16 identification number on the certification label, or a vehicle 17 identification number assigned by the director of finance. A 18 bill of sale and Manufacturers Statement of Origin for the 19 20 frame, engine, and transmission must be presented and retained as a part of the permanent county registration records. If a 21 Manufacturers Statement of Origin is not available for the 22

Description:

Defines "after market motorcycle frame" and allows the County director of finance to assign a vehicle identification number to a motorcycle with an aftermarket frame. DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO MOTOR VEHICLE REGISTRATION.

PURPOSE: To defines "after market motorcycle frame" and allow the County director of finance to assign a vehicle identification number to a motorcycle with an aftermarket frame. Except for special interest vehicles, reconstructed vehicles and motorcycles with an after market frame, the bill disallows the registration of uncertified motor vehicles and devices.

MEANS: Amend sections 286-2 and 286-42 (a), Hawaii Revised Statutes.

JUSTIFICATION: When Act 225, Session Laws of Hawaii 2002, was passed, the wording of the sections noted above was changed in a manner that allows motorcycles that were manufactured for offroad use only to be registered for use on public roads. This bill is an effort to correct this situation.

> The definition of a motorcycle is so general that there is a very wide variety of vehicles that can fit it. Two examples are: off-road dirt motorcycles and pocket motorcycles. Mixing vehicles like these with the vehicle population on public roads causes safety hazards that were not intended by Act 225 or the motorcycle manufacturers. Legitimate motorcycle manufacturers place a label on off-road motorcycles indicating that they are not made for use on public roads. This bill is intended to exclude these vehicles from registration. The bill is also designed to allow registration of vehicles that were certified for use on public roads when they were originally manufactured and subsequently modified by owners in a manner (changing the frame) that removed the original

certification and VIN, and uncertified vehicles that were built by hobbyists.
