### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 188, Hawaii Revised Statutes, is		
2	amended by adding a new section to be appropriately designated		
3	and to read as follows:		
4	" <b>§188- Pacific blue marlin; prohibited</b> . (a) No person		
5	shall possess Pacific blue marlin for the purpose of sale,		
6	importation, exportation, trade, or distribution.		
7	(b) Notwithstanding subsection (a), any person who holds a		
8	license or permit issued by the department of land and natural		
9	resources to conduct research for education purposes, and who		
10	sells, offers for sale, imports, exports, trades, or distributes		
11	Pacific blue marlin in furtherance of such research shall not be		
12	subject to the penalties in this section.		
13	(c) Any person violating this section or any rule adopted		
14	pursuant to this section shall be penalized as follows:		
15	(1) For a first offense, by an administrative fine of not		
16	less than \$5,000 and not more than \$15,000;		
17	(2) For a second offense, by an administrative fine of not		
18	less than \$15,000 and not more than \$35,000. In

14	(d)	In addition to any penalties imposed under subsection

17	188-70, and may be assessed administrative fees and costs, and		
18	attorney's fees and costs.		
19	<u>(e)</u>	The department may adopt rules pursuant to chapter 91	
20	necessary	for the purposes of this section.	
21	<u>(f)</u>	As used in this section, "Pacific blue marlin" means	
22	any fish	of the species Makaira nigricans (blue marlin).
