A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH BENEFIT EXCHANGE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The federal Patient Protection and Affordable Care Act of 2010 provides for the establishment of health 2 3 insurance exchanges by 2014 that will facilitate the purchase 4 and sale of, and provide a connection between buyers and sellers 5 of, federally qualified health insurance plans. The intent of 6 these health insurance exchanges is to reduce the number of 7 uninsured, provide a transparent marketplace and consumer education, and assist individuals with access to programs, 8 premium assistance tax credits, and cost-sharing reductions. 9

10 The legislature finds that, under Hawaii's current prepaid 11 health care act, the State already enjoys an overall healthier 12 population, lower rates of uninsured than on the mainland, and 13 generally lower premium costs. The prepaid health care act has 14 been successful and it is imperative that the prepaid health 15 care act work in tandem with health insurance exchanges.

16 The State is already in receipt of a federal grant to plan 17 for the design and implementation of a Hawaii-based health 18 insurance exchange and a task force has also been convened for HB1201 HD1 HMS 2011-1824

this purpose. This Act requires the Hawaii-based nonprofit 1 2 health insurance exchange to work collaboratively with the task force to propose legislation for consideration during the 3 regular session of 2012 to implement a framework that ensures 4 the State's compliance with federal law. This will enable the 5 6 legislature to provide policy direction and operational guidance as the State continues working towards the 2014 health insurance 7 8 exchange implementation deadline.

Because the federal grant will soon become available and 9 the United States Secretary of Health and Human Services will 10 need to determine whether Hawaii is on track to implement a 11 health insurance exchange, the legislature finds it is prudent 12 to move forward during the regular session of 2011 with an 13 enabling statute. This framework will allow the legislature to 14 make the most appropriate policy decisions for the 15 implementation of the health insurance exchange during the 16 17 regular session of 2012.

18 The legislature finds that the people of Hawaii will be 19 best served by a health insurance exchange that is operated in 20 Hawaii. Accordingly, the purpose of this Act is to create a 21 private, nonprofit health insurance exchange.

6	§431: -101 Title. This article shall be known and may			
7	be cited as the Hawaii Health Benefit Exchange Act.			
8	§431: -102 Definitions. As used in this article:			
9	"Board" means the board of directors of the Hawaii health			
10	benefit exchange.			
11	"Commissioner" means the insurance commissioner.			
12	"Exchange" means the Hawaii health benefit exchange.			
13	"Federal act" means the Patient Protection and Affordable			
14	Care Act (Public Law 111-148), as amended by the Health Care and			
15	Education Reconciliation Act of 2010 (Public Law 111-152), and			
16	any amendments and related regulations or guidance.			
17	"Health carrier" means an entity subject to the insurance			
18	laws and rules of this State or the jurisdiction of the

5	"Qualified health plan" means a health benefit plan offered			
6	by a health carrier that has in effect a certification that the			
7	plan meets the criteria for certification described in section			
8	1311(c) of the federal act.			
9	"Secretary" means the United States Secretary of Health and

11	§431: -103 Hawaii health benefit exchange;			
12	establishment; purpose. (a) There is established as a			
13	nonprofit body corporate, the Hawaii health benefit exchange.			
14	(b) The purpose of the Hawaii health benefit exchange			
15	shall include but not be limited to:			
16	(1) Facilitating the purchase and sale of qualified health			
17	plans in compliance with the federal act; and			
18	(2) Those purposes set forth by the legislature.			
19	§431: -104 Board of directors; composition; operation.			
20	(a) The Hawaii health benefit exchange shall be governed by a			
21	board of directors, which shall be composed of nine members as			
22	follows:

1	(1)	Three members, by and with the advice and consent of	
2		the senate, shall be appointed by the governor for a	
3		term of four years; provided that two of the three	
4		members shall be appointed from the community;	
5	(2)	Three members, by and with the advice and consent of	
6		the senate, shall be appointed by the governor from a	
7		list of nominations submitted by the president of the	
8		senate and shall serve for a term of four years;	
9		provided that of the initial appointees, one shall be	
10		appointed for a two-year term; and	
11	(3)	Three members, by and with the advice and consent of	
12		the senate, shall be appointed by the governor from a	
13		list of nominations submitted by the speaker of the	
14		house of representatives and shall serve for a term of	
15		four years; provided that of the initial appointees,	
16		one shall be appointed for a two-year term.

including travel expenses, incurred in the performance of their
 duties.

3 (c) The board shall implement the exchange in accordance
4 with this article and shall be authorized to establish
5 procedures for the operation of the exchange.

6 (d) The board shall meet no less than quarterly on a
7 schedule established by the chairperson. Five members of the
8 board shall constitute a quorum and the affirmative vote of five
9 members shall be necessary for any action of the board.

(e) The board shall adopt rules in accordance with chapter
91 regarding conflict of interest and recusal procedures. The
rules shall include a requirement for the recusal of a member
regarding action on any official matter if the member has any
financial involvement or interest in that matter. All recusals
shall be in advance of any board action and shall specify in
writing the reason and date of the recusal.

17 (f) The board shall prepare and submit an annual report to
18 the legislature no later than twenty days prior to the convening
19 of each regular legislative session.

20 §431: -105 Officers and employees of the exchange. The
21 board shall appoint, without regard to chapters 76 and 89, an
22 executive director who shall serve at the pleasure of the board HB1201 HD1 HMS 2011-1824

1 and who shall be responsible for the day-to-day operations and 2 management of the exchange. The board may also appoint any 3 other officers and employees, without regard to chapters 76 and 4 89, that may be necessary in administering the affairs of the exchange. The board, at its discretion, shall prescribe 5 6 employees' duties, responsibilities, salaries, holidays, 7 vacations, leaves, hours of work, and working conditions. The board may grant any other benefits to its employees that it 8 9 deems necessary.

10 §431: -106 Powers. The exchange, under the direction of
11 the board, shall have the powers and authorities of a private,
12 nonprofit entity.

13 §431: -107 Funding. As required by section
14 1311(d)(5)(A) of the federal act, the exchange shall be self15 sustaining by January 1, 2015. The board may establish fees to
16 offset administrative costs.

17 §431: -108 Effect on the Prepaid Health Care Act.
18 Nothing in this article shall diminish or alter in any manner
19 the provisions of chapter 393.

20 §431: -109 Rules. The commissioner shall adopt rules in
21 accordance with chapter 91 to implement this article; provided
22 that the rules shall not conflict with or prevent the

application of regulations promulgated by the Secretary under
 the federal act."

SECTION 3. (a) The Hawaii health benefit exchange shall 3 work with the state health insurance exchange task force 4 5 established in the department of commerce and consumer affairs to comply with Federal Domestic Assistance grant number 93:525 6 7 to develop policies and necessary proposed legislation to 8 implement the duties and responsibilities of the Hawaii health 9 benefit exchange in compliance with the Patient Protection and Affordable Care Act, as amended by the Health Care and Education 10 Reconciliation Act of 2010, taking into consideration chapter 11 12 393, Hawaii Revised Statutes.

13 Twenty days prior to the convening of the regular (b) session of 2012, the board of directors of the Hawaii health 14 benefit exchange shall submit proposed legislation amending the 15 new article established under this Act to provide for the 16 17 implementation of a health insurance exchange in Hawaii that complies with the Patient Protection and Affordable Care Act, as 18 amended by the Health Care and Education Reconciliation Act of 19 2010 and any federal authorization granted to the State pursuant 20 21 to that act.

22 SECTION 4. This Act shall take effect upon its approval. HB1201 HD1 HMS 2011-1824
