# A BILL FOR AN ACT

RELATING TO PERINATAL CARE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature established a perinatal clinic, Perinatal Addiction Treatment of Hawaii, as a three-year pilot 2 project in 2006 in response to the high rate of methamphetamine 3 use by pregnant women. The clinic provides comprehensive 4 prenatal, delivery, and postpartum care and social services to 5 women who have a history of substance use. Since it was 6 established, the clinic has been successful in engaging this difficult-to-reach population of women. It supports them in 8 decreasing their substance use and helps them deliver healthy 9 infants that they are capable of parenting. Despite the high 10 average cost of medical care for a single very low weight infant 11 in its first year of life -- over \$200,000 -- the clinic is cost-12 effective. However, this highly successful clinic is not 13 sustainable without funding from the State. 14 15

The Perinatal Addiction Treatment of Hawaii clinic provides its patients with prenatal care that addresses their addictions in a small, dedicated, nonjudgmental setting. Patients are also provided with social service support, parenting education, and HB LRB 11-0913.doc

- 1 transportation. Since its creation, Perinatal Addiction
- 2 Treatment of Hawaii has cared for over one hundred eighty women,
- 3 and it is expected to provide services to over sixty women with
- 4 addictions in 2011.
- 5 The legislature initially appropriated \$400,000. Because of
- 6 funding delays, only one year, from April 2007 to June 2008, was
- 7 funded. Act 147, Session Laws of Hawaii 2007, provided \$200,000
- 8 for the period from July 2008 to August 2009. In March 2009, the
- 9 Perinatal Addiction Treatment of Hawaii clinic was awarded a
- 10 grant from the department of health to provide perinatal support
- 11 services and triage, but due to budget restrictions, the grant
- 12 was not funded. The clinic has continued to provide services
- 13 through individual donations and small grants made to its tax-
- 14 exempt charitable social service agency.
- While Perinatal Addiction Treatment of Hawaii is not a
- 16 substance abuse treatment program, its unique integration of
- 17 prenatal, clinical, and social services results in a cessation of
- 18 substance use in most women. It also assists some women to
- 19 recognize that they require residential substance abuse
- 20 treatment and facilitates their admission into an appropriate
- 21 program.

1	Since	e its creation, the Perinatal Addiction Treatment of
2	Hawaii pi	lot project has achieved the following results:
3	(1)	The effects of substance use and the associated risk
4		factors (i.e., poverty, homelessness, interpersonal
5		violence, tobacco and alcohol use, and co-occurring
6		medical and behavioral health illness) on birth
7		outcomes were largely ameliorated by the prenatal care
8		at the Perinatal Addiction Treatment of Hawaii clinic;
9	(2)	Patients in the program were overwhelmingly likely to
10		stop using drugs, deliver healthy infants, maintain
11		custody, choose a long-term birth control method, and
12		choose to work on or develop skills six months after
13		delivery;
14	(3)	While infants born to women who received services at
15		Perinatal Addiction Treatment of Hawaii were four to
16		five times more likely to suffer preterm birth and low
17		birth weight, the birth outcomes at Perinatal Addiction
18		Treatment of Hawaii were consistent with state and
19		national averages for all births;
20	(4)	Eighty per cent of women treated at Perinatal
21		Addiction Treatment of Hawaii became abstinent from

drugs and over ninety per cent significantly decreased

1		substance use within eight weeks of using Perinatal
2		Addiction Treatment of Hawaii services;
3	(5)	Ninety-four per cent of women treated were tested to
4		be substance-free at the time of birth;
5	(6)	Of the women who had positive drug tests at the time
6		of birth, over half chose to enter a residential
7		substance abuse treatment program, often noting that
8		their experience at Perinatal Addiction Treatment of
9		Hawaii contributed to their readiness to accept
10		treatment;
11	(7)	Ninety-six per cent of women treated maintained
12		custody of their infants eight weeks after delivery
13		(fifty-seven per cent had previously lost custody of
14		at least one child); and
15	(8)	The nine-month repeat pregnancy rate for women who
16		maintained custody of their infants was lower than
17		state and national averages; fifty per cent of the
18		women who lost custody of their infants were pregnant
19		again within nine months of having given birth.

21	perinatal	addiction clinic that integrates prenatal and
22	postpartu	m obstetric clinical services, addiction medicine

- 1 services, and social services. The state medicaid program is
- 2 billed for allowable clinical services. Although funding sources
- 3 are available for medical services, essential social services
- 4 that are provided by the clinic remain unfunded. State moneys
- 5 are needed to fund these services.
- 6 The purpose of this Act is to appropriate funds to continue
- 7 the Perinatal Addiction Treatment of Hawaii pilot program.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$200,000 or so much
- 10 thereof as may be necessary for fiscal year 2011-2012 and the
- 11 same sum or so much thereof as may be necessary for fiscal year
- 12 2012-2013 for the Perinatal Addiction Treatment of Hawaii clinic
- 13 for case management and other social services that it provides.
- 14 The sums appropriated shall be expended by the department
- 15 of health for the purposes of this Act.
- 16 SECTION 3. The moneys appropriated by this Act shall be
- 17 used for:
- 18 (1) Case management of pregnant and recently delivered (up
- 19 to six months) women struggling with substance use,
- 20 including alcohol, to be provided by a master's degree
- 21 level social worker or nurse experienced in the area
- of substance abuse treatment;

1	(2)	Addiction medicine services that may not be medicaid
2		funded;
3	(3)	Therapeutic childcare during clinic appointments and
4		classes or activity groups;
5	(4)	Transportation assistance to and from clinic
6		appointments and classes or activity groups;
7	(5)	Group classes and activities to support women in
8		achieving their goals of giving birth to healthy
9		infants that they are capable of parenting; and
10	(6)	Administrative support to provide a dedicated space,
11		integration of services, and support of education and
12		research in the area of effective treatment of
13		perinatal addiction.
14	SECT	ION 4. This Act shall take effect on July 1, 2011.
