A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Chapter 356D, Hawaii Revised Statutes, is

 amended by adding a new section to be appropriately designated

 and to read as follows:

 "§356D- Community facilities; fees. (a) Each unit

 shall be assessed a community facilities maintenance fee of at
- 6 least one per cent of the community facility expenses.
- 7 (b) The authority shall notify all tenants in writing of
- 8 any increase in the community facilities maintenance fee at
- 9 least thirty days prior to an increase.
- (c) The authority shall adopt rules in accordance with
- 11 chapter 91 for the purposes of this section."
- 12 SECTION 2. Section 356D-8, Hawaii Revised Statutes, is
- 13 amended to read as follows:
- 14 "[f]§356D-8[f] Acquisition, use, and disposition of
- 15 property. (a) The authority may acquire any real or personal
- 16 property or interest therein by purchase, exchange, gift, grant,
- 17 lease, or other means from any person or government to provide

- 1 public housing. Exchange of real property shall be in
- 2 accordance with section 171-50.
- 3 (b) The authority may own or hold real property. All real
- 4 property owned or held by the authority shall be exempt from
- 5 mechanics' or materialmen's liens and also from levy and sale by
- 6 virtue of an execution, and no execution or other judicial
- 7 process shall issue against the property of the authority nor
- 8 shall any judgment against the authority be a charge or lien
- 9 upon its real property; provided that this subsection shall not
- 10 apply to nor limit the right of obligees to foreclose or
- 11 otherwise enforce any mortgage of the authority or the right of
- 12 obligees to pursue any remedies for the enforcement of any
- 13 pledge or lien given by the authority on its rents, fees, or
- 14 revenues. The authority and its property shall be exempt from
- 15 all taxes and assessments.
- 16 (c) The authority may lease or rent all or a portion of
- 17 any public housing project and establish and revise the rents or
- 18 charges therefor[-]; provided that the authority shall:
- (1) Establish a schedule setting forth the minimum rent
- for state public housing units by number of bedrooms
- 21 and type of housing project;

1	(2)	Charge no less than \$300 per month for any state
2		public housing unit; and
3	<u>(3)</u>	Annually adjust the minimum rent by the percentage, if
4		any, by which the consumer price index for the year
5		exceeds the consumer price index for the prior year.
6		The consumer price index for any year is the average
7		of the consumer price index for all urban consumers as
8		determined by the United States Department of Labor
9		for the applicable county, or if not published for the

- 3 SECTION 3. Section 356D-42, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "[+] §356D-42[+] Housing; tenant selection. Subject to the
- 6 following limitations and preferences, the authority shall
- 7 select tenants [upon the basis of those in greatest need] for
- 8 the particular housing. The authority may limit the tenants of
- 9 any state low-income housing project to classes of persons when
- 10 required by federal law or regulation as a term or condition of
- 11 obtaining assistance from the federal government. [Within the
- 12 priorities established by the authority recognizing need,
- 13 veterans | Veterans with a permanent disability of ten per cent
- 14 or more as certified by the United States Department of Veterans
- 15 Affairs, the dependent parents of the veteran, and the deceased
- 16 veteran's widow shall be given first preference."
- 17 SECTION 4. Section 356D-43, Hawaii Revised Statutes, is
- 18 amended by amending subsection (a) to read as follows:
- 19 "(a) Notwithstanding any other law to the contrary, the
- 20 authority shall fix the rates of the rentals for dwelling units
- 21 and other facilities in state low-income housing projects
- 22 provided for by this subpart, at rates that will produce

- 1 revenues that will be sufficient to pay all expenses of
- 2 management, operation, and maintenance, including the cost of
- 3 insurance, a proportionate share of the administrative expenses
- 4 of the authority to be fixed by it, and the costs of repairs,
- 5 equipment, and improvements, to the end that the state low-
- 6 income housing projects shall be and always remain self-
- 7 supporting[-]; provided that the rates of the rentals shall be
- 8 no less than the minimum rent set forth in section 356D-8. The
- 9 authority, in its discretion, may fix the rates in amounts as
- 10 will produce additional revenues (in addition to the foregoing)
- 11 sufficient to amortize the cost of the state low-income housing
- 12 project or projects, including equipment, over a period or
- 13 periods of time that the authority may deem advisable."
- 14 SECTION 5. Statutory material to be repealed is bracketed
- 15 and stricken. New statutory material is underscored.
- 16 SECTION 6. This Act shall take effect on July 1, 2030.

Authorizes the Hawaii Public Housing Authority to assess a fee to all units for community facility maintenance. Requires minimum rent schedule for housing projects and annual Consumer Price Index adjustments of minimum rent. Effective July 1, 2030. (HB1303 HD2)
