A BILL FOR AN ACT

RELATING TO SMALL BOAT HARBORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of 2 land and natural resources, through its division of boating and 3 ocean recreation, operates and manages twenty one harbors, fifty 4 boat ramps, 2,122 moorings and berths, and nineteen piers spread 5 throughout the various counties of the State. The legislature further finds that these ocean recreation facilities, in light of the present demand, are in short supply and in most cases are 7 8 in dire need of long overdue repair and maintenance. 9 facilities are in such disrepair that they cannot be used and 10 are hazards to public safety. 11 One of these facilities, the Ala Wai boat harbor, has been 12 a recent recipient of some badly needed repair and replacement 13 of floating docks; however, the need for further maintenance 14 remains unfulfilled. In spite of its needs, the Ala Wai boat 15 harbor includes certain assets within its facilities that are 16 under-utilized and if properly developed can potentially generate revenues that can benefit not only its continued 17 improvement and maintenance but also the rest of the facilities 18

- 17 the fast lands or submerged lands of the Ala Wai boat harbor
- 18 issued pursuant to a request for proposals shall be governed by
- 19 this section.

- 21 harbor that may be leased include the following:

18	SECTION 3. Section 200-2.5, Hawaii Revised Statutes, is							
19	amended to read as follows:

21	properties. (a) Notwithstanding any law to the contrary, the

- 2 proposals, or by direct negotiation pursuant to section 171-
- 3 59[7] and chapter 190D, for private development, management, and
- 4 operation; provided that any lease of fast lands or submerged
- 5 lands pursuant to a request for proposals shall be subject to
- 6 the requirements of section 200- (b), (c), and (e) regardless
- 7 of which boating facility the fast or submerged lands are
- 8 attached. For the purpose of this section, the term "state
- 9 boating facility" means a state small boat harbor, launching
