# A BILL FOR AN ACT

RELATING TO SMALL BOAT HARBORS.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the department of 2 land and natural resources, through its division of boating and 3 ocean recreation, operates and manages twenty-one harbors, fifty 4 boat ramps, 2,122 moorings and berths, and nineteen piers spread 5 throughout the various counties of the State. The legislature 6 further finds that these ocean recreation facilities are in 7 short supply and in many cases are in dire need of long overdue 8 repair and maintenance. Some facilities are in such disrepair 9 that they cannot be safely used.

10 One of these facilities, the Ala Wai boat harbor, has been 11 a recent recipient of some badly needed repair and replacement 12 of floating docks; however, the need for further maintenance at 13 Ala Wai and other boat harbors remains unfulfilled. In spite of 14 its needs, the Ala Wai boat harbor includes certain assets 15 within its facilities that are underused and if properly 16 developed could potentially generate revenues that would enable 17 not only its own continued improvement and maintenance but the 18 improvement and maintenance of the rest of the facilities now HB1312 SD2 LRB 11-3062.doc

1 operated by the department of land and natural resources' 2 division of boating and ocean recreation. 3 In these times of economic malaise and with the State 4 facing a massive budget deficit over the next biennium, a 5 further decline in the State's small boat harbors would be a 6 huge loss that the State cannot allow. 7 The purpose of this Act is to authorize the department of 8 land and natural resources to use the request for proposals 9 process to enter into a public-private partnership for the 10 development of portions of Ala Wai boat harbor facilities that 11 are presently underused, to maximize the revenue potential from 12 those facilities. 13 SECTION 2. Chapter 200, Hawaii Revised Statutes, is 14 amended by adding a new section to be appropriately designated 15 and to read as follows: 16 "§200-Ala Wai boat harbor; leases. (a) Any lease of 17 the fast lands or submerged lands of the Ala Wai boat harbor 18 issued pursuant to a request for proposals shall be governed by 19 this section. 20 The fast lands and submerged lands of the Ala Wai boat (b) 21 harbor that may be leased include the following:

1 existing state boating facility by public auction, a request for 2 proposals, or by direct negotiation pursuant to section 3 171-59[ $_{\tau}$ ] and chapter 190D, for private development, management, 4 and operation [-]; provided that any lease of fast lands or 5 submerged lands pursuant to a request for proposals shall be subject to the requirements of section 200- (b), (c), and (e) 6 7 regardless of what boating facility the fast or submerged lands 8 are attached. For the purpose of this section, the term "state 9 boating facility" means a state small boat harbor, launching 10 ramp, offshore mooring, pier, wharf, landing, or any other area 11 under the jurisdiction of the department pursuant to this 12 chapter.

(b) The permissible uses under any lease disposed of under this section shall be consistent with the purpose for which the land was set aside by the governor pursuant to section 171-11. Permissible uses may include any use that will complement or support the <u>ocean recreation or</u> maritime activities of state boating facilities.

19 (c) Disposition of public lands [of] upon which state
20 boating facilities <u>are</u> constructed, maintained, and operated in
21 accordance with this chapter shall not exceed a maximum term of
22 fifty-five years.
