A BILL FOR AN ACT

RELATING TO TELECOMMUNICATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Act 199, Session Laws of Hawaii 2010, 1 established a broadband working group to develop procedures for 2 streamlining permitting functions that are applicable to the 3 development of broadband services and broadband technology. 4 of the discussion items of the working group is to exempt from 5 many of the permitting requirements the installation of new or 6 upgraded broadband infrastructure along existing conduits that 7 8 are already used for telecommunications.
- 9 The purpose of this Act is to speed the deployment of high10 speed broadband technology in Hawaii by exempting construction
 11 of broadband infrastructure from certain permitting
- 12 requirements.
- 13 SECTION 2. From January 1, 2012, to January 1, 2017,
- 14 actions relating to the installation, improvement, construction,
- 15 or development of infrastructure relating to broadband service
- 16 or broadband technology, including the interconnection of
- 17 telecommunications cables, shall be exempt from county
- 18 permitting requirements and state permitting and approval

4	SECTION 4. No later than January 1, 2016, the director of
5	commerce and consumer affairs, in consultation with the
6	administrator of the cable television division, shall:
7	(1) Review the state of broadband communications in Hawaii
8	and the exemptions made pursuant this Act; and
9	(2) Make a recommendation whether to extend the exemptions
10	provided by this Act.
11	The director of commerce and consumer affairs shall submit a
12	report of the director's findings and recommendations, along
13	with any proposed legislation, to the legislature no later than
14	twenty days prior to the convening of the regular session of
15	2016.
