### A BILL FOR AN ACT

RELATING TO A SURCHARGE FOR INDIGENT SERVICES.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the 2007 study,
Assessment of Civil Legal Needs and Barriers of Low- and
Moderate-Income People of Hawaii, determined that four out of
five low- and moderate-income residents did not have their legal
needs met and that legal service providers are only able to
assist one in three who contact them for assistance.

7 The legislature also finds that more funding is necessary 8 to increase the delivery of legal services. Additional funds 9 could be generated by increasing the surcharge for indigent 10 legal services, as recommended by the Access to Justice Hui in 11 its Community Wide Action Plan: Ten Steps to Increase Access to 12 Justice in Hawaii by 2010.

13 SECTION 2. Section 607-5.7, Hawaii Revised Statutes, is14 amended by amending subsections (a) and (b) as follows:

15 "(a) In addition to the costs and fees prescribed in 16 section 607-5, any person in a civil action in the circuit court 17 who is required to pay an initial filing fee shall pay an 18 additional surcharge of [\$25] \$65 at the time of the person's HB LRB 11-1190.doc

1	initial filing. Initial filings for which this surcharge shall
2	be assessed include[+]:
3	(1) Complaints, petitions, interventions, applications for
4	special proceedings, and answers containing one or

6	(2) [ <del>Third party</del> ] <u>Third-party</u> complaints, but shall not
7	include post-judgment civil process.
8	(b) In addition to the costs and fees prescribed in
9	section 607-4, any person [who_files an action for_summary
10	possession in the district court] in a civil action in the
11	district court who is required to pay an initial filing fee
12	shall pay an additional surcharge of [ $\$10$ ] $\$35$ at the time of
13	the person's initial filing. Any person in a civil action in
14	the [ <del>supreme_court</del> ] <u>courts of appeal</u> who is required to pay an
15	initial filing fee [ <del>also</del> ] shall <u>also</u> pay an additional surcharge
16	of [ $\frac{25}{5}$ ] $\frac{565}{5}$ at the time of the person's filing. No surcharge
17	shall be assessed against:
18	(1) Small claims cases;
19	(2) Petitions for temporary restraining orders;
20	(3) Petitions for protective orders;
21	(4) Any party who has received the court's permission to

1 (5) Any party proceeding on behalf of the county or State. 2 Surcharges subject to this section shall be limited to one 3 payment per party."
