A BILL FOR AN ACT

RELATING TO PLANNING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. (a) There is established within the governor's office for administrative purposes a temporary task force to 2 review and update the Hawaii state planning act and the 3 planning, programming, and budgeting system of the State. The 4 governor shall convene the task force within thirty days after 5 the effective date of this Act. 6 (b) The task force shall be composed of: 7 The chairperson of the senate ways and means committee (1)8 or the chairperson's designee; 9 The chairperson of the house finance committee or the 10 (2)chairperson's designee; 11 The chairperson of the senate water, land, and housing 12 (3)committee or the chairperson's designee; 13 14 (4)The chairperson of the house water, land, and ocean resources committee or the chairperson's designee; 15 The chairperson of the senate economic development and (5) 16 technology committee or the chairperson's designee; 17

1 (1)Select the chairperson of the task force from among 2 the members themselves; and Serve without compensation, but may be reimbursed for 3 (2)necessary expenses, including travel expenses, 4 incurred in the performance of their official duties 5 under this Act. 6 The chairperson of the task force may select 7 (d) additional task force members at the chairperson's discretion. 8 The office of planning shall provide all 9 (e) administrative, technical, professional, and clerical support 10 required by the task force for matters pertaining to the review 11 and update of the state planning act. 12 The department of budget and finance shall provide all 13 administrative, technical, professional, and clerical support 14 required by the task force for matters pertaining to the review 15 and update of the planning, programming, and budgeting system. 16 The task force shall submit a report of its findings 17 (f) and recommendations, including proposed legislation, to the 18 legislature no later than twenty days prior to the convening of 19 each regular session, beginning with the 2012 regular session. 20 The task force shall cease to exist on June 30, 2015. 21 (q)
