A BILL FOR AN ACT

RELATING TO HIGHWAYS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 243-4, Hawaii Révised Statutes, is
 amended by amending subsection (a) to read as follows:

"(a) Every distributor, in addition to any other taxes 3 4 provided by law, shall pay a license tax to the department of 5 taxation for each gallon of liquid fuel refined, manufactured, 6 produced, or compounded by the distributor and sold or used by 7 the distributor in the State or imported by the distributor, or 8 acquired by the distributor from persons who are not licensed 9 distributors, and sold or used by the distributor in the State. 10 Any person who sells or uses any liquid fuel, knowing that the 11 distributor from whom it was originally purchased has not paid 12 and is not paying the tax thereon, shall pay such tax as would 13 have applied to such sale or use by the distributor. The rates 14 of tax imposed are as follows:

15 (1) For each gallon of diesel oil, 2 cents;
16 (2) For each gallon of gasoline or other aviation fuel
17 sold for use in or used for airplanes, 2 cents;

3 SECTION 2. Statutory material to be repealed is bracketed4 and stricken. New statutory material is underscored.

5 SECTION 3. This Act shall take effect on July 1, 2011; 6 provided that the amendments made to section 243-4(a), Hawaii 7 Revised Statutes, by section 1 of this Act shall not be repealed when section 243-4(a), Hawaii Revised Statutes, is repealed and 8 9 reenacted on December 31, 2012, pursuant to section 5 of Act 10 103, Session Laws of Hawaii 2007, as amended by Section 3 of Act 11 198, Session Laws of Hawaii 2009; provided further that this Act 12 shall be repealed on June 30, 2017, and section 243-4(a), Hawaii 13 Revised Statutes, shall be reenacted in the form in which it 14 read on the day prior to the enactment of this Act.
