A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. A reliable irrigation system is the lifeblood 2 of Hawaii's agricultural industry. To ensure that Hawaii's 3 crops receive a steady and dependable supply of water, 4 sufficient funding is needed to maintain and improve Hawaii's 5 irrigation system. 6 The purpose of this Act is to provide additional funding 7 needed for improvements to irrigation systems throughout the 8 State. SECTION 2. (a) 9 The director of finance is authorized to 10 issue general obligation bonds in the sum of \$9,960,000 or so 11 much thereof as may be necessary and the same sum or so much 12 thereof is necessary is appropriated for fiscal year 2011-2012 13 for the purpose of making capital improvements to irrigation 14 systems as follows: **15** (1)\$500,000 for the Waiahole irrigation system; \$1,850,000 for the Waimanalo irrigation system; **16** (2) 17 (3) \$2,000,000 for the Molokai irrigation system;
