BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 11-15, Hawaii Revised Statutes, is 1 amended by amending subsection (a) to read as follows: 2 "(a) Any person qualified to and desiring to register as a 3 voter in any county shall make and subscribe to an application 4 in the form of an affidavit. 5 The affidavit shall contain the following information: 6 (1) Name; 7 Social security number; (2) (3) Date of birth; 9 Residence, including mailing address; (4)10 That the residence stated in the affidavit is not (5) 11 simply because of the person's presence in the State 12 but that the residence was acquired with the intent to 13 make Hawaii the person's legal residence with all the 14 accompanying obligations therein; and 15 (6) That the person is a citizen. 16 An application to register to vote shall include a space to

SECTION 3. Section 15-4, Hawaii Revised Statutes, is

- 1. By amending subsection (a) to read:
- 2 "(a) Any person registered to vote may request an absentee
- 3 ballot or permanent absentee ballot in person or in writing from
- 4 the clerk [not earlier than on the sixtieth day and] at any time
- 5 but not later than 4:30 p.m. on the seventh day prior to the
- 6 election. Any mailed requests for an absentee ballot or
- 7 permanent absentee ballot shall be mailed by the person directly
- 8 to the clerk. The clerk may waive any or all of the foregoing
- 9 requirements in special cases as provided in the rules adopted
- 10 by the chief election officer.
- 11 The request shall include information such as the person's

Requires an application to register to vote in person or by mail-in to include a space to request a permanent absentee ballot. Removes time limit on requesting an absentee or permanent absentee ballot but not later than 4:30 p.m. on the seventh day prior to the election. Effective January 7, 2059. (HB1613 HD1)
