## A BILL FOR AN ACT

RELATING TO THE HAWAII OCCUPATIONAL SAFETY AND HEALTH LAW.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 396-10, Hawaii Revised Statutes, is
- 2 amended as follows:
- 3 1. By amending subsections (b) to (i) to read:
- 4 "(b) Any employer who has received an order or citation
- 5 for a serious violation of any standard or rule adopted pursuant
- 6 to this chapter shall be assessed a civil penalty of not more
- 7 than [\$7,000] \$7,700 for each violation.
- 8 (c) Any employer who has received an order or citation for
- 9 a violation of any standard or rule adopted pursuant to this
- 10 chapter, and the violation is specifically determined not to be
- 11 of a serious nature, may be assessed a civil penalty of up to
- 12 [\$7,000] \$7,700 for each violation.
- (d) Each day a violation continues shall constitute a
- 14 separate violation, except that during an abatement period only,
- 15 no additional penalty shall be levied against the employer.
- (e) Any employer who violates any of the posting
- 17 requirements prescribed under this chapter shall be assessed a
- 18 civil penalty of up to [\$7,000] \$7,700 for each violation.

- 4 of not less than [\$5,000] \$5,500 nor more than [\$70,000] \$77,000
- 5 for each violation.
- 6 (g) Any employer convicted of wilful or repeated violation
- 7 of any standard, rule, citation, or order issued under authority
- 8 of this chapter resulting in the death of an employee shall be
- 9 punished by a fine of not more than [\$70,000] \$77,000 or by
- 10 imprisonment for not more than six months, or both, except that
- 11 if the conviction is for a violation committed after a first
- 12 conviction, punishment shall be by a fine of not more than
- [\$70,000] \$77,000 or by imprisonment for not more than one year,
- 14 or both. Failure to correct a violation for which an order or
- 15 citation of arrest has been issued shall be evidence of wilful
- 16 conduct.
- 17 (h) Any employer who has received an order for violation
- 18 under section 396-8(e) may be assessed a civil penalty of not
- 19 more than [\$1,000] \$1,100 for each violation.
- 20 (i) Any person who gives advance notice of any inspection
- 21 to be conducted under this chapter, without authority from the
- 22 director or the director's designees shall, upon conviction, be
