A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

HB231 HD1 HMS 2011-1951

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 356D, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" §356D- Guests; visitor passes. (a) Any visitor that
5	consistently and predominantly trespasses on the premises of a
6	public housing project shall acquire a visitor pass from the
7	manager of the public housing project or the manager's designee
8	upon entering the premises; provided that a manager shall issue
9	a visitor pass only to a visitor invited onto the premises by an
10	adult tenant of the public housing project.
11	(b) The authority shall adopt rules pursuant to chapter 91
12	for the purposes of this section."
13	SECTION 2. Section 708-813, Hawaii Revised Statutes, is
14	amended by amending subsection (1) to read as follows:
15	"(1) A person commits the offense of criminal trespass in
16	the first degree if:
17	(a) That person knowingly enters or remains unlawfully:
18	(i) In a dwelling; or

1		(ii) In or upon the premises of a hotel or apartment
2		building;
3	(b)	That person:
4		(i) Knowingly enters or remains unlawfully in or upon
5		premises that are fenced or enclosed in a manner
6		designed to exclude intruders; and
7		(ii) Is in possession of a firearm, as defined in
8		section 134-1, at the time of the intrusion; $[\Theta r]$
9	(c)	That person enters or remains unlawfully in or upon
10		the premises of any public school as defined in
11		section 302A-101, or any private school, after
12		reasonable warning or request to leave by school
13		authorities or a police officer; provided [however,
14		such] that a warning or request to leave shall be
15		unnecessary between 10:00 p.m. and 5:00 a.m.; or
16	<u>(d)</u>	That person enters or remains unlawfully in or upon
17		the premises of any public housing project, as defined
18		in section 356D-1 or 356D-91, after reasonable warning
19		or request to leave by housing management or
20		authorities or a police officer; provided that
21		remaining on the premises of any public housing
22		project without a visitor's pass, pursuant to section

1 356D- , shall be prima facie evidence of a violation 2 of this section." 3 SECTION 3. (a) The Hawaii public housing authority shall 4 establish a two-year pilot project for Mayor Wright homes. The objective of the pilot project shall be to provide residents of 5 6 Mayor Wright homes with increased safety and security from 7 trespassers. 8 The Hawaii public housing authority shall report (b) 9 submit a report on the safety and security measures implemented 10 and its findings and recommendations from the pilot project to 11 the legislature no later than twenty days prior to the convening 12 of the 2013 regular session. (c) The pilot project shall cease to exist on June 30, 13 14 2013. SECTION 4. There is appropriated out of the general 15 revenues of the State of Hawaii the sum of \$ 16 or so much 17 thereof as may be necessary for fiscal year 2011-2012 and the same sum or so much thereof as may be necessary for fiscal year 18 2012-2013 for the pilot project for Mayor Wright homes. 19 20 The sums appropriated shall be expended by the Hawaii public housing authority for the purposes of this Act. 21

Public Housing; Visitor Pass; Trespassing

Description:

Requires certain visitors to public housing projects to receive a visitor pass upon entering a public housing project. Establishes the non-possession of a visitor pass as prima facie evidence of criminal trespass in the first degree. Establishes a pilot project for increased safety and security at Mayor Wright Homes. Appropriates funds. Effective July 1, 2011. (HB231 HD1)
