## A BILL FOR AN ACT

RELATING TO PUBLIC PROCUREMENT.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 103D-305, Hawaii Revised Statutes, is
  amended to read as follows:

  "\$103D-305 Small purchases; prohibition against parceling.
- 4 (a) Procurements of less than \$100,000 for goods or services,
- 5 or \$250,000 for construction, except as provided in subsection
- 6 (d), shall be made in accordance with procedures set forth in
- 7 rules adopted by the policy board that are designed to ensure
- 8 administrative simplicity and as much competition as is
- 9 practicable; provided that multiple expenditures shall not be
- 10 created at the inception of a transaction or project so as to
- 11 evade the requirements of this chapter; and provided further
- 12 that procurement requirements shall not be artificially divided
- 13 or parceled so as to constitute a small purchase under this
- 14 section.
- 15 (b) Procurements of greater than \$50,000 for construction
- 16 under subsection (a) shall require security by a performance
- 17 bond delivered to the purchasing agency that is:
- 18 (1) In a form prescribed by the rules of the policy board;
