## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

. 1	SECTION 1. Section 171-36, Hawaii Revised Statutes, is
2	amended by amending subsection (b) to read as follows:
3	"(b) The board, from time to time, upon the issuance or
4	during the term of any intensive agricultural, aquaculture,

6	industrial lease, may:
7	(1) Modify or eliminate any of the restrictions specified
8	in subsection (a);
9	(2) Extend or modify the fixed rental period of the lease;
10	provided that the aggregate of the initial term and
11	any extension granted shall not exceed sixty-five
12	years; or
13	(3) Extend the term of the lease,
14	to the extent necessary to qualify the lease for mortgage
15	lending or guaranty purposes with any federal mortgage lending
16	agency, to qualify the lessee for any state or private lending

to amortize the cost of substantial improvements to the demised premises that are paid for by the lessee without institutional financing, such extension being based on the economic life of the improvements as determined by the board or an independent appraiser; provided that the approval of any extension shall be subject to the following:

7 (1)The demised premises have been used substantially for 8 the purpose for which they were originally leased; 9 The aggregate of the initial term and any extension (2)10 granted shall not be for more than fifty-five years; 11 (3) In the event of a reopening, the rental for any 12 ensuing period shall be the fair market rental at the 13 time of reopening;

14 (4) Any federal or private lending institution shall be
15 qualified to do business in the State;

16 (5) Proceeds of any mortgage or loan shall be used solely
17 for the operations or improvements on the demised
