A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the 2 overrepresentation of native Hawaiians in the criminal justice 3 system is an issue that has not been adequately addressed. 4 The discussion of native Hawaiian social well-being has 5 highlighted some of that community's greatest strengths: the 6 inclusive nature of 'ohana, the cohesive power of communities, 7 and the growing sense of cultural identity. However, the 8 multiple stressors and social imbalances within the native 9 Hawaiian community have led to troubling outcomes, including 10 antisocial, self-destructive, and criminal behavior, that are 11 amplified by an enforcement and justice system in which 12 inequality is an ongoing reality.

adults. Native Hawaiian children of inmates are also at
 increased risk of growing up without a parent to support them
 through critical stages of growth and development. Moreover,
 deviant activities which lead to arrests and incarceration, such
 as crime and drug use, directly influence the safety and
 stability of communities, which may further hinder the
 educational prospects for native Hawaiian children and adults.

8 The purpose of this Act is to require a correctional impact 9 statement to accompany any bill that is filed in a regular 10 session that passes second reading in the originating body and 11 that creates a new criminal offense, significantly changes an 12 existing public offense or the penalty for an existing offense, 13 or changes existing sentencing, parole, or probation procedures. 14 SECTION 2. Chapter 21, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to 15 16 read as follows:

17 "<u>§21-</u> <u>Correctional impact statement.</u> (a) A
18 <u>correctional impact statement shall accompany any bill that is</u>
19 <u>filed in a regular session that passes second reading in the</u>
20 <u>originating body and that proposes to create a new offense,</u>
21 <u>amend an existing offense or the penalty thereto, or change</u>
22 <u>existing sentencing, parole, or probation procedures.</u>
