## A BILL FOR AN ACT

RELATING TO WORKERS' COMPENSATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 386-1, Hawaii Revised Statutes, is 2 amended by amending the definition of "employment" to read as 3 follows: 4 ""Employment" [means]: Means any service performed by an individual for 5 (1) another person under any contract of hire or 6 7 apprenticeship, express or implied, oral or written, whether lawfully or unlawfully entered into. 8 Ιt 9 includes service of public officials, whether elected 10 or under any appointment or contract of hire express 11 or implied [-]; ["Employment" does] 12 13 Does not include: (2) 14 [-(1)] (A) Service for a religious, charitable, educational, 15 or nonprofit organization if performed in a 16 voluntary or unpaid capacity; 17 [<del>(2)</del>] (B) Service for a religious, charitable, educational,

14	educational, or nonprofit organization" means a corporation,		
15	unincorporated association, community chest, fund, or foundation		
16	organized and operated exclusively for religious, charitable, or		
17	educational purposes, no part of the net earnings of which inure		
18	to the benefit of any private shareholder or individual."		
19	SECTION 2. This Act does not affect rights and duties that		
20	matured, penalties that were incurred, and proceedings that were		
<b>2</b> 1	begun before its effective date.
