11	(b) Any contract or agreement, or portion thereof, that		
12	violates subsection (a) shall be deemed void and unenforceable.		
13	(c) As used in this section:		
14	"Indemnitee" means:		
15	(1) A person who enters into a transportation contract or		
16	agreement to use the services of, or permit entry onto		
17	their premises to, a motor carrier; or
