A BILL FOR AN ACT

RELATING TO HOME HEALTH AGENCIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The department of health currently licenses
home health agencies, but uses a definition for "home health
agency" that is overly restrictive. As a result, some agencies
that provide home health services are not licensed.

5 "Home health agency" is generally defined as an 6 organization that provides medical care by nurses and other 7 licensed professionals under a physician's direction to people 8 in their own homes. It is differentiated from "home care 9 agency", which provides non-medical care by unlicensed personnel 10 under the direction of the client to people in their own homes. 11 Home care includes assistance with bathing, preparing meals, and 12 transportation.

13 The department of health is preparing to license home care 14 agencies pursuant to Act 21, First Special Session Laws of 15 Hawaii 2009, which requires home care agencies to be licensed. 16 Section 321-11, Hawaii Revised Statutes, authorizes the 17 department of health to license home health agencies, and the 18 department has adopted rules for that purpose. Title 11, Hawaii Administrative Rules, defines "home health 1 2 agency" for the purpose of licensing. According to that 3 definition, a home health agency is one that provides "skilled 4 nursing services and other therapeutic services". The 5 department of health has interpreted that definition to mean 6 that a home health agency provides both skilled nursing services 7 and other therapeutic services. An agency that provides only 8 skilled nursing services or only other therapeutic services is 9 not deemed to be a home health agency subject to licensing by 10 the department. This interpretation puts the public in 11 jeopardy, since there are unlicensed agencies that are providing 12 health care.

13 The purpose of this Act is to statutorily establish an 14 accurate and meaningful definition of "home health agency" and 15 to require the department of health to license these agencies so 16 that all agencies that provide skilled nursing services or other 17 therapeutic services, or both, are licensed.

18 SECTION 2. Chapter 321, Hawaii Revised Statutes, is 19 amended by adding a new section to be appropriately designated 20 and to read as follows:

4	(b) The department shall adopt rules in accordance with
5	chapter 91 that shall:
6	(1) Protect the health, safety, and civil rights of
7	clients of home health agencies; and
8	(2) Provide for the licensure of home health agencies.
9	(c) For purposes of this section:
10	"Home health agency" means a public or proprietary agency,
11	a private, nonprofit organization, or a subdivision of an agency
12	or organization that is engaged in providing skilled nursing
13	services, other therapeutic services, or both under a
14	physician's direction to clients in the client's residence.
15	"Home health agency" does not apply to an individual, even when
16	the individual is incorporated as a business, or an unpaid or
17	stipended volunteer."
18	SECTION 3. New statutory material is underscored.
19	SECTION 4. This Act shall take effect on July 1, 2050.
