BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. (a) There is established the coastal memorials
2	task forc	e within the department of land and natural resources
3	for admin	istrative purposes. The task force shall consist of
4	the follo	wing eleven members:
5	(1)	The chairperson of the board of land and natural
6		resources or the chairperson's designee;
7	(2)	The director of transportation or the director's
8		designee;
9	(3)	A member of the house of representatives, designated
10		by the speaker of the house of representatives;
11	(4)	A member of the senate, designated by the senate
12		president;
13	(5)	One representative from each county, designated by the
14		respective county's mayor;
15	(6)	A member of the community as designated by the speaker
16		of the house of representatives;
17	(7)	A member of the community, designated by the president
18		of the senate; and

1	(8)	A member of the community, designated by the governor.	
2	The	members of the task force shall elect a chairperson	
3	from among its membership.		
4	(b)	The coastal memorials task force shall:	
5	(1)	Review and evaluate the practice of erecting coastal	
6		memorials with respect to the safety of beach users;	
7	(2)	Develop standards to regulate the practice of erecting	
8		coastal memorials;	
9	(3)	Consider the size, placement, and duration of coastal	
10		memorials in its review; and	
11	(4)	Report its findings and recommendations to the	
12		legislature, including any proposed legislation, no	
13		later than twenty days prior to the convening of the	
14		regular session of 2012.	
15	(c)	Members of the coastal memorials task force shall	
16	serve without compensation but shall be reimbursed for expenses,		
17	including	travel expenses necessary for the performance of their	
18	duties.		
19	(d)	The legislative reference bureau shall assist the	
20	coastal m	emorials task force in preparing its findings,	
21	recommendations, and proposed legislation; provided that the		
22	chairpers	on of the task force shall submit the necessary

2	drafting no later than November 1, 2011.
3	(e) For purposes of this Act, "coastal memorials" mean
4	impromptu structures built on public land along coastal areas of
5	the state on occasion, to commemorate the death of another
6	person.
7	(f) The coastal memorials task force shall cease to exist
8	on June 30, 2012.
9	SECTION 2. This Act shall take effect upon its approval.
