A BILL FOR AN ACT

RELATING TO TRESPASS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that visitor-guide
2	websites and visitor-guide publications may encourage visitors
3	to intrude onto private or public property to experience an
4	attraction or activity. The representations made by these
5	websites and publications potentially put visitors at risk by
6	describing attractions or activities without adequately
7	explaining the inherent dangers associated with them or that
8	they are located on or require crossing private or public
9	property from which the public is excluded, sometimes resulting
10	in serious injury to or the death of the visitor.
11	The legislature further finds that because of the publicity
12	from and encouragement by visitor-guide websites and visitor-
13	guide publications, private and public landowners may be unable
14	to reasonably prevent intruders from traveling on or through
15	their land to gain access to the dangerous attraction or

activity.

1	Accordingly, the purpose of this Act is to:		
2	(1)	Apply a duty to warn to authors or publishers of	
3		visitor-guide websites or visitor-guide publications	
4		describing attractions to warn the public of dangerous	
5		conditions typical to the area; provided that a	
6		publisher shall only have such a duty if the publisher	
7		participates in the authoring of the website;	
8	(2)	Require the authors or publishers to defend and	
9		indemnify the owner or occupier of the private or	
10		public land from any liability arising from injury to	
11		or the death of the person; and	
12	(3)	Create a task force to identify problem areas on all	
13		islands that pose a risk of serious injury or death to	
14		visitors.

- 2 of the area if the conditions pose a risk of serious injury or
- 3 death, provided that a publisher shall have a duty to warn only
- if the publisher participates in authoring the website or 4

- 6 The author or publisher described in subsection (a)
- 7 shall also defend and indemnify the owner or occupier of private
- or public land in the State from which the public is excluded in 8
- 9 any cause of action or proceeding arising on account of serious
- 10 injury or death.
- 11 As used in this section: (c)
- 12 "Land in the State from which the public is excluded" means
- 13 any area fenced to prohibit entry by the general public, or
- 14 posted with a sign stating "No Trespassing" or a substantially
- 15 similar message.
- 16 "Visitor-guide publication" means any published book,
- **17** pamphlet, magazine, handout, mailer, or advertisement, whether
- disseminated via hard copy or electronic distribution, that 18
- 19 provides information about a visitor destination, geographic
- 20 destination, or natural attraction on privately or publicly
- 21 owned land in the State from which the public is excluded.

- 19 legislature no later than twenty days prior to the convening of
- 20 the regular session of 2012.
- 21 (f) The task force shall terminate on May 10, 2012.
