A BILL FOR AN ACT

RELATING TO TRESPASS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that visitor guide 2 websites and visitor quide publications may inadvertently invite 3 visitors to trespass on remote private property to experience an 4 attraction or activity. The representations made by these websites and guide publications put visitors at potential risk 5 6 by describing attractions or activities without adequately 7 explaining the inherent dangers associated with them, that may 8 result in serious injury or death to the visitor.

9 The legislature further finds that a private landowner may 10 own or manage large tracts of land in natural areas that hikers 11 and nature enthusiasts tend to seek out. If the landowner does 12 not have the personnel necessary to secure the area, even posted 13 "No Trespassing" signs may be unheeded.

14 The purpose of this Act is to establish a task force to 15 identify problem areas on the various islands and recommend 16 remedies to reduce the incidence of trespass over privately held 17 or public lands.

1 Visitor guide websites and visitor guide publications; (12)2 and 3 (13)Hawaii's publishing industry. 4 (C)The task force shall meet in large and small groups, 5 as appropriate, to develop findings and recommendations to 6 reduce the incidence of trespass over privately held or public 7 lands to access remote or scenic destinations as the result of 8 information published on visitor guide websites and in visitor 9 quide publications. 10 (d) The legislative reference bureau may provide 11 assistance to the task force in the compilation and publication 12 of the findings and recommendations of the task force, but shall 13 not provide administrative support to the task force. 14 (e) The task force shall submit its report to the 15 legislature no later than twenty days prior to the convening of 16 the regular session of 2012. 17 SECTION 3.
