## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The auditor shall conduct an analysis of the

be limited to an examination of financial records, overall 1 2 financial health and the use of allocated resources in relation 3 to the services provided, programming results and effectiveness, and operating expenses. 4 5 The auditor shall submit findings and recommendations to 6 the legislature prior to July 1, 2012. 7 SECTION 3. The department of commerce and consumer affairs 8 shall make funds from the compliance resolution fund available to the auditor to conduct the contracted performance review or 9 10 audit required under section 2 of this Act. 11 SECTION 4. There is appropriated out of the compliance 12 resolution fund the sum of \$ or so much thereof as may be necessary for fiscal year 2011-2012 to be transferred to the 13 14 audit revolving fund for the auditor to contract for the 15 performance review or audit specified in section 2 of this Act. 16 The sum appropriated shall be expended by the department of 17 commerce and consumer affairs for the purposes of this Act. 18 SECTION 5.
