1 calculated before any tax refund or tax credit is 2 authorized by the legislature, pursuant to article 3 VII, section 6 of the Hawaii Constitution, that is 4 provided during the same regular session as the 5 transfer depositing such moneys to the emergency and budget reserve fund; provided that transfers shall not 6 7 be made to the emergency and budget reserve fund 8 whenever the balance of the emergency and budget 9 reserve fund is equal to or more than ten per cent of 10 general fund revenues for the preceding fiscal year. 11 The transfer shall be executed by the director of 12 finance;

13 provided that all moneys deposited into the emergency and budget 14 reserve fund under paragraphs (1) and (2) and all moneys 15 deposited under paragraph (3) shall be kept in separate and 16 distinct accounts."

17 SECTION 2. Statutory material to be repealed is bracketed18 and stricken. New statutory material is underscored.

SECTION 3. This Act shall take effect on June 30, 2011;
provided that the amendment made to section 328L-3, Hawaii
Revised Statutes, by section 1 of this Act shall not be repealed
when section 328L-3, Hawaii Revised Statutes, is reenacted on
