# A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that a special fund needs 2 to be established for the state fire council for administration 3 of the reduced ignition propensity cigarette program. Money for 4 the fund should come from the fees collected by the state fire 5 council under the program as provided for in section 132C-4, Hawaii Revised Statutes. Since the program's implementation on 6 7 September 30, 2009, approximately \$390,000 has been collected. 8 The special fund will be used to fund staff positions within the state fire council for an administrator and an assistant to 9 10 execute the statutory duties of the program.

SECTION 2. Chapter 132C, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

15 special fund. (a) There is established in the state treasury a

| 4  | SECTION 3. Section 132C-4, Hawaii Revised Statutes, is          |
| 5  | amended by amending its title and subsection (a) to read as     |

| 8  | (a) Each manufacturer shall submit to the state fire council    |
| 9  | written certification attesting that each cigarette has been    |
| 10 | tested in accordance with, and has met the performance standard |
| 11 | required under section 132C-3. The description of each          |
| 12 | cigarette listed in the certification shall include:            |
| 13 | (1) The brand or trade name on the package;                     |
| 14 | (2) Style, such as light or ultra light;                        |
| 15 | (3) Length in millimeters;                                      |
| 16 | (4) Circumference in millimeters;                               |
| 17 | (5) Flavor, such as menthol, if applicable;                     |
| 18 | (6) Filter or nonfilter;  |
| 19 | (7) Package description, such as a soft pack or box;            |
| 20 | (8) The mark approved pursuant to subsection (b);               |
