## A BILL FOR AN ACT

RELATING TO HEALTH INSURANCE.

	BE II ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:
1	SECTION 1. The purpose of this Act is to continue
2	permitting small accident and health or sickness insurers, who
3	lack coercive power in the marketplace, to bundle together
4	different classes of insurance, such as health, dental, and
5	vision. Under these circumstances, bundling provides broader
6	health care coverage in single unified policies, ultimately
7	resulting in lower overall premiums; fostering greater
8	competition within the Hawaii insurance marketplace; and
9	providing consumers with greater flexibility, coverage, and
10	pricing options.
11	Act 227, Session Laws of Hawaii 2008, which amended the
12	Insurance Code to permit such bundling, contains a sunset clause
13	that will repeal Act 227 on June 30, 2011. The legislature
14	finds that the hundling exemption for small accident and health

14 15 or sickness insurers has benefitted Hawaii consumers and that it 16 has not had an adverse effect on competition because the affected insurers lack coercive market power. Consequently, the **17** 18 purpose of this Act is to remove the sunset clause and keep in

- 17 and stricken.
- 18 SECTION 4. This Act shall take effect on January 7, 2059.
