### A BILL FOR AN ACT

RELATING TO SCHOOL REGISTRATION FEES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is 2 amended by adding two new sections to be appropriately 3 designated and to read as follows: "§302A-A Public school registration fees. (a) The board 4. shall assess an annual registration fee of \$25 for each student 5 attending a public school, to be paid upon registration at the 6 beginning of the school year. The registration fees shall be 7 deposited into the public school registration fee special fund, 8 established under section 302A-B; provided that any student who 9 has paid the annual registration fee that school year shall not 10 be subject to payment of another registration fee if the student 11 12 transfers to another public school or public charter school 13 during the school year. (b) This section shall not apply to: 14 (1) 15 Students who qualify for free school lunches; or (2) Home schooled students, unless the home schooled 16 student participates in any activities with a public 17 18 school.

16	The charter school review panel shall assess an annual
17	registration fee of \$25 for each student attending a public
18	charter school, to be paid upon registration at the beginning of

20	the public charter school registration fee special fund,
21	established under section 302B-B; provided that any student who

4	(b) This section shall not apply to:
5	(1) Students who qualify for free school lunches; or
6	(2) Home schooled students, unless the home schooled

9	<u>§302B-B</u> Public charter school registration fee special
10	fund. (a) There is established a public charter school
11	registration fee special fund within the state treasury, into
12	which shall be deposited all registration fees collected by the
13	office under section 302B-A.
14	(b) Moneys in the public charter school registration fee
15	special fund shall be appropriated by the legislature to the
16	office, which shall make the funds available to each public
17	charter school according to enrollment.
18	(c) The teachers of each public charter school shall

20	SECTION 3. If any part of this Act is found to be in
21	conflict with federal requirements that are a prescribed
22	condition for the allocation of federal funds to the State, the

conflicting part of this Act is inoperative solely to the extent 1 of the conflict and with respect to the agencies directly 2 3 affected, and this finding does not affect the operation of the remainder of this Act in its application to the agencies 4 concerned. The rules under this Act shall meet federal 5 requirements that are a necessary condition to the receipt of 6 7 federal funds by the State. SECTION 4. In codifying the new sections added by sections 8 1 and 2 of this Act, the revisor of statutes shall substitute 9 appropriate section numbers for the letters used in designating 10 the new sections in this Act. 11 12 SECTION 5. This Act shall apply to public schools and public charter schools beginning in school year 2012-2013. 13 SECTION 6. New statutory material is underscored. 14 SECTION 7. This Act shall take effect on July 1, 2011. 15 16 17
