### A BILL FOR AN ACT

RELATING TO HEALTH PLANNING.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Article IX, section 1 of the Hawaii
   Constitution states that "The State shall provide for the
- 3 protection and promotion of the public health."
- 4 Accordingly, the state health planning and development
- 5 agency was created by Act 159, Session Laws of Hawaii 1975, and
- 6 codified as chapter 323D, Hawaii Revised Statutes, the purpose
- 7 of which is to establish a health planning and resources
- $oldsymbol{8}$  development program to promote accessibility for all the people
- 9 of the State to quality health care services at reasonable cost.
- 10 The purpose of this Act is to clarify the philosophy behind
- 11 the formulation of the state health services and facilities plan
- 12 and require that the adoption or amendment of the plan be
- 13 subject to the rulemaking requirements of chapter 91, Hawaii
- 14 Revised Statutes.
- 15 SECTION 2. Section 323D-15, Hawaii Revised Statutes, is
- 16 amended to read as follows:
- 17 "\$323D-15 State health services and facilities plan.
- There shall be a state health services and facilities plan,

- 1 which shall address the health care needs of the State,
- 2 including inpatient care, health care facilities, and special
- 3 needs. The plan shall not address competition as a means for
- 4 achieving its purpose, but rather depict the most economical and
- 5 efficient system of care commensurate with adequate quality of
- 6 care, and shall include standards for utilization of health care
- 7 facilities and major medical equipment. The utilization
- 8 standards in the plan shall clearly detail the methodology for
- 9 determining capacity and excess capacity in the State for each
- 10 category of health care facility and major medical equipment
- 11 regulated. The plan shall provide for the reduction or
- 12 elimination of underutilized, redundant, or inappropriate health
- 13 care facilities and health care services. The adoption or
- 14 amendment of the plan shall be subject to chapter 91."
- 15 SECTION 3. The state health planning and development
- 16 agency shall conduct a review of its existing state health
- 17 services and facilities plan and conduct proceedings in
- 18 accordance with chapter 91, Hawaii Revised of Statutes, to adopt
- 19 the plan and any amendments made to the plan.
- 20 The state health planning and development agency shall
- 21 submit a report to the legislature not later than twenty days
