### A BILL FOR AN ACT

RELATING TO THE CONVEYANCE TAX.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that during the present
2	budget crisis, higher priorities than land conservation and the
3	natural area reserve system exist. The legislature also finds
4	that the rental housing trust fund has a balance that is
5	sufficient for its purposes.
6	The purpose of this Act is to temporarily suspend the
7	distribution of a portion of the conveyance tax to the land
8	conservation fund and rental housing trust fund and reduce the
9	portion distributed to the natural area reserve fund.
10	SECTION 2. Section 173A-5, Hawaii Revised Statutes, is
11	amended by amending subsection (d) to read as follows:
12	"(d) The appropriate percentage identified under section
13	247-7 of all taxes imposed and collected under chapter 247 shall
14	be deposited in or credited to the fund [every fiscal year.]
15	after June 30, 2013."
16	SECTION 3. Section 247-7, Hawaii Revised Statutes, is
