## A BILL FOR AN ACT

RELATING TO THE CONVEYANCE TAX.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that during the present 2 budget crisis, higher priorities than land conservation exist. 3 The purpose of this Act is to temporarily suspend the 4 distribution of a portion of the conveyance tax to the land 5 conservation fund. 6 SECTION 2. Section 173A-5, Hawaii Revised Statutes, is 7 amended by amending subsection (d) to read as follows: 8 "(d) The appropriate percentage identified under section 9 247-7 of all taxes imposed and collected under chapter 247 shall 10 be deposited in or credited to the fund [every fiscal-year.] 11 after June 30, 2013." 12 SECTION 3. Section 247-7, Hawaii Revised Statutes, is

13 amended to read as follows:

14 "\$247-7 Disposition of taxes.
