A BILL FOR AN ACT

RELATING TO AGRICULTURE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that Hawaii's beekeepers 2 are experiencing devastating losses in their industry due to a 3 combination of bad weather and the infestation of varroa mites, 4 nosema spores, and small hive beetles. Unofficial counts 5 indicate that thousands of bee colonies in Hawaii have died off, 6 but the exact numbers remain unknown. Currently, state 7 agricultural officials do not compile statistics on the 8 production of queen bees in Hawaii, in part because the industry 9 is small and also because of issues relating to proprietary 10 information.

11 The purpose of this Act is to allow beekeepers to register 12 certain information with the department of agriculture, which 13 shall be confidential subject to the limitations on 14 confidentiality imposed under chapter 92F, Hawaii Revised 15 Statutes.

1	SECTION 2. Chapter 142, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated

4	" §142- Beekeepers; registration. (a) Beekeepers may
5	register with the department of agriculture, on forms prescribed
6	and prepared by the department, which shall include the
7	following information:
8	(1) The name, address, and contact information for the
9	beekeeper; and
10	(2) Other information that may assist the department in
11	compiling accurate information on Hawaii's beekeeping
12	industry.
13	(b) The department of agriculture shall keep registration
14	information confidential subject to the limitations on
15	confidentiality imposed under chapter 92F; provided that the
16	name and business address of each registrant shall be made
17	publicly available by the department; and provided further that
18	the department may compile statistics based on the information,
19	pursuant to section 141-1.

1	(c) The registration shall be effective for a period of
2	one year, and shall be renewed at the end of the one-year
3	period."
4	SECTION 3. The department of agriculture shall establish
5	an apiary program, which may include the following positions, to
6	carry out the purposes of this Act:
7	(1) One apiary specialist;
8	(2) One apiary planner; and
9	(3) Two apiary technicians.
10	SECTION 4. The department of agriculture shall report to
11	the legislature no later than twenty days prior to the convening
12	of the regular session of 2013 on the effectiveness of beekeeper
13	registration in keeping accurate statistics on the beekeeping
14	industry, including any proposed legislation or recommendations
15	for amendments to the registration system or process.
16	SECTION 5. New statutory material is underscored.
17	SECTION 6. This Act shall take effect on July 1, 2011.
