## A BILL FOR AN ACT

RELATING TO AGRICULTURE.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The legislature finds that Hawaii's beekeepers 1 SECTION 1. 2 are experiencing devastating losses in their industry due to a 3 combination of bad weather and the infestation of varroa mites, 4 nosema spores, and small hive beetles. Unofficial counts 5 indicate that thousands of bee colonies in Hawaii have died off, 6 but the exact numbers remain unknown. Currently, state 7 agricultural officials do not compile statistics on the production of queen bees in Hawaii, in part because the industry 8 9 is small and also because of issues relating to proprietary 10 information.

11 The purpose of this Act is to allow beekeepers to register 12 with the department of agriculture, with the information to be 13 kept confidential.

SECTION 2. Chapter 142, Hawaii Revised Statutes, is amended by adding a new section to be appropriately designated and to read as follows:

 17 "<u>\$142-</u> <u>Beekeepers; registration.</u> (a) Beekeepers may

1	and prepared by the department, which shall include the
2	following information:
3	(1) The name, address, and contact information for the
4	beekeeper; and
5	(2) Other information that may assist the department in
6	compiling accurate information on Hawaii's beekeeping
7	industry.
8	(b) The information shall be confidential and the
9	department shall not disclose the information; provided that the
10	name and business address of each registrant shall be made
11	publicly available by the department; and provided further that
12	the department may compile statistics based on the information,
13	pursuant to section 141-1.
14	(c) The registration shall be effective for a period of
15	one year, and shall be renewed at the end of the one-year
16	period."
17	SECTION 3. There is appropriated out of the general
18	revenues of the State of Hawaii the sum of \$350,000 or so much
19	thereof as may be necessary for fiscal year 2011-2012 and the
20	same sum or so much thereof as may be necessary for fiscal year
21	2012-2013 to establish an apiary program, including permanent
22	positions as follows:

1 (1) One apiary specialist; 2 One apiary planner; and (2) 3 (3) Two apiary technicians. 4 The sums appropriated shall be expended by the department 5 of agriculture for the purposes of this Act. 6 SECTION 4. The department of agriculture shall report to 7 the legislature no later than twenty days prior to the convening 8 of the regular session of 2013 on the effectiveness of the 9 beekeeper registration in keeping accurate statistics on the 10 beekeeping industry, and any recommendations for amendments. 11 SECTION 5. New statutory material is underscored. 12 SECTION 6. This Act shall take effect upon its approval; 13 provided that section 3 of this Act shall take effect on July 1, 14 2011.
