BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Chapter 141, Hawaii Revised Statutes, is

11	(1)	Determining county expenditures that qualify for state
12		matching funds and the ratio of state matching funds
13		provided for each dollar expended by the counties;
14	(2)	Determining, if requests for state matching funds
15		exceed the funding available, the most appropriate way
16		to distribute available funds to the counties; and
17	(3)	Determining the process by which counties submit
18		requests for state matching funds and establishing

1	deadlines or timelines, if any, and other similar		
2	details of the program.		
.3	(b) There is established within the state treasury the		
4	state matching funds for county agricultural support special		
5	fund which shall be administered by the department, and into		
6	which shall be deposited legislative appropriations, grants and		
7	gifts, all interest earned or accrued on moneys deposited in the		
8	fund, and any other moneys made available to the fund. The		
9	state matching funds for county agricultural support special		
10	fund shall be used to provide state matching funds under the		
11	program specified in subsection (a)."		
12	SECTION 2. There is appropriated out of the general		
13	revenues of the State of Hawaii the sum of \$ or so		
14	much thereof as may be necessary for fiscal year 2011-2012 and		
15	the same sum or so much thereof as may be necessary for fiscal		
16	year 2012-2013 to be deposited into the state matching funds for		
17	county agricultural support special fund.		
18	SECTION 3. There is appropriated out of the state matching		
19	funds for county agricultural support special fund the sum of		
20	\$ or so much thereof as may be necessary for fiscal		
21	year 2011-2012 and the same sum or so much thereof as may be		
22	necessary for fiscal year 2012-2013 for the purposes of

3 SECTION 4. The sums appropriated shall be expended by the4 department of agriculture for the purposes of this Act.

5 SECTION 5. New statutory material is underscored.

6 SECTION 6. This Act shall take effect upon its approval;
7 provided that sections 2, 3, and 4 shall take effect on July 1,
