A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to ensure that 2 Hawaii is consistent with the efforts of federal agencies to 3 control health care-associated infections. This Act also ensures that the department of health has access to health care-4 5 associated infection data reported by Hawaii's health care 6 providers to the federal government. In addition, this Act requires the Hawaii legislature to be updated on federal and 7 8 state efforts to report health care-associated infections. 9 SECTION 2. Chapter 321, Hawaii Revised Statutes, is 10 amended by adding a new section to be appropriately designated 11 and to read as follows: Health care-associated infection reporting. (a) 12 "§321-Each health care facility in Hawaii that is certified by the 13 Centers for Medicare and Medicaid Services shall report 14 15 information about health care-associated infections to the 16 Centers for Disease Control and Prevention's national healthcare safety network, as specified in the rules of the Centers for 17 18 Medicare and Medicaid Services.

1	(b) Health care facilities subject to this section shall
2	authorize the Centers for Disease Control and Prevention to
3	allow the department to access health care-associated infection
4	data reported by those health care facilities to the national
5	healthcare safety network.
6	(c) The department may adopt rules pursuant to chapter 91
7	to require that health care-associated infections that are
8	multidrug-resistant be reported to the department through the
9	national healthcare safety network. The rules shall specify
10	which health care facilities are required to report those health
11	care-associated infections that are multidrug-resistant through
12	the national healthcare safety network, as well as the patient
13	populations that are to be targeted in the reports. The first
14	year of reporting required under this subsection shall be a
15	pilot test of the reporting system and shall not be reported or
16	disclosed to the public.
17	(d) The department shall preserve patient confidentiality
18	and shall not disclose to the public any patient level data
19	obtained from any health care facility.
20	(e) The department may issue reports to the public about
21	health care-associated infections that aggregate data so that no
22	individual patient can be identified. The reports may identify

2	methodology or any part of the methodology developed by the
3	Centers for Disease Control and Prevention and the Centers for
4	Medicare and Medicaid Services for national reporting of health
5	care-associated infections.
6	(f) Health care-associated infection information held by
7	the department as a result of reporting under this section is
8	not subject to subpoena, discovery, or introduction into
9	evidence in any civil or criminal proceeding; provided that
10	health care-associated infection information otherwise available
11	from other sources is not immune from subpoena, discovery, or
12	introduction into evidence through those sources solely because
13	the information was provided as required by this section.
14	(g) Beginning on June 30, 2013, and no later than June 30
15	of each year, thereafter, the department shall prepare a public
16	report, in accordance with this section, containing information
17	pertaining to health care-associated infections in Hawaii for
18	the previous calendar year.
19	(h) For the purposes of this section:
20	"Department" means the department of health.
