A BILL FOR AN ACT

RELATING TO HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. There is appropriated out of the general
 revenues of the State of Hawaii the sum of \$ or so
 much thereof as may be necessary for fiscal year 2011-2012 and
 the same sum or so much thereof as may be necessary for fiscal
 year 2012-2013 to improve existing affordable housing stock and
 increase affordable housing units in the State of Hawaii.

7 The sums appropriated shall be expended by the Hawaii8 community development authority for the purposes of this Act.

9 SECTION 2. There is appropriated out of the general
10 revenues of the State of Hawaii the sum of \$ or so
11 much thereof as may be necessary for fiscal year 2011-2012 and
12 the same sum or so much thereof as may be necessary for fiscal
13 year 2012-2013 to improve existing affordable housing stock and
14 increase affordable housing units in the State of Hawaii.

15 The sums appropriated shall be expended by the Hawaii 16 housing finance and development corporation for the purposes of 17 this Act.



1 SECTION 3. There is appropriated out of the general 2 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2011-2012 and 3 the same sum or so much thereof as may be necessary for fiscal 4 year 2012-2013 to improve existing public housing stock and 5 6 increase public housing units in the State of Hawaii. 7 The sums appropriated shall be expended by the Hawaii 8 public housing authority for the purposes of this Act. SECTION 4. There is appropriated out of the general 9 10 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2011-2012 and 11 the same sum or so much thereof as may be necessary for fiscal 12 year 2012-2013 to improve existing affordable housing stock and 13 14 increase affordable housing units in the city and county of 15 Honolulu. The sums appropriated shall be expended by the city and 16 county of Honolulu for the purposes of this Act. 17 18 SECTION 5. There is appropriated out of the general 19 revenues of the State of Hawaii the sum of \$ or so

20 much thereof as may be necessary for fiscal year 2011-2012 and 21 the same sum or so much thereof as may be necessary for fiscal

year 2012-2013 to improve existing affordable housing stock and 1 increase affordable housing units in the county of Maui. 2 The sums appropriated shall be expended by the county of 3 4 Maui for the purposes of this Act. SECTION 6. There is appropriated out of the general 5 6 revenues of the State of Hawaii the sum of \$ or so much thereof as may be necessary for fiscal year 2011-2012 and 7 the same sum or so much thereof as may be necessary for fiscal 8 year 2012-2013 to improve existing affordable housing stock and 9 10 increase affordable housing units in the county of Hawaii. The sums appropriated shall be expended by the county of 11 12 Hawaii for the purposes of this Act. SECTION 7. There is appropriated out of the general 13 revenues of the State of Hawaii the sum of \$ 14 or so much thereof as may be necessary for fiscal year 2011-2012 and 15 the same sum or so much thereof as may be necessary for fiscal 16 year 2012-2013 to improve existing affordable housing stock and 17 increase affordable housing units in the county of Kauai. 18

19 The sums appropriated shall be expended by the county of20 Kauai for the purposes of this Act.
