A BILL FOR AN ACT

RELATING TO THE UNIVERSITY OF HAWAII.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 304A, Hawaii Revised Statutes, is 2 amended by adding a new subpart to part II to be appropriately 3 designated and to read as follows: 4 HAWAII MEDICAL DOCTOR LOANS 5 §304A-A Hawaii medical doctor loans; eligibility; amounts. 6 There is created the Hawaii medical doctor loan program to be 7 administered by the University of Hawaii, to provide financial 8 support to: 9 (1) Students who complete a state-approved medical school 10 program at the University of Hawaii; or (2) Graduates of a medical school who have received 11 12 medical training from a Hawaii-based medical program, 13 and who agree to practice in rural areas of the State, as 14 designated by the University of Hawaii. Loans shall be awarded 15 by the university to students on a competitive basis. **16** amount to be loaned to a student shall be determined by the

board of regents based upon need for financial aid and proof of

acceptance into a state-approved medical school program at the

- 1 university. The maximum aggregate amount of loans that a
- 2 student may receive under this program shall be an amount
- 3 equivalent to tuition payments and costs of textbooks and other
- 4 instructional and laboratory materials necessary to complete a
- 5 state-approved medical school program.
- 6 §304A-B Repayment of loans; late fees; rural area practice
- 7 and loan repayment waiver; collection agency. (a) All loans
- 8 made under this subpart shall bear interest at five per cent
- 9 simple interest. Repayment of principal and interest shall
- 10 commence one year after graduation or three months after a loan
- 11 recipient ceases to:
- 12 (1) Be enrolled in a state-approved medical school program
- at the university; or
- 14 (2) Receive medical training from a Hawaii-based medical
- 15 program, and
- 16 shall be paid in periodic installments within a six-year period.
- 17 (b) The university shall charge late fees and all other
- 18 reasonable costs for the collection of delinquent loans.
- 19 (c) Upon a showing of proof that the loan recipient has
- 20 completed a state-approved medical school program or has
- 21 received medical training from a Hawaii-based medical program
- 22 and is practicing as a medical doctor in a rural area of the

- 1 State, as designated by the university, one-tenth of the total
- 2 amount of the loan and interest shall be waived for every year
- 3 of the first five years, and the remaining balance shall be
- 4 waived after the sixth year that a loan recipient practices
- 5 medicine in a rural area of the State, as designated by the
- 6 University of Hawaii.
- 7 (d) A loan recipient subject to this section who fails to
- 8 practice medicine in a rural area of the State, as designated by
- 9 the university, for a minimum of six consecutive years from the
- 10 loan recipient's original date of employment, excluding
- 11 temporary leaves of absence, shall be subject to a withdrawal of
- 12 any waiver of future repayments, and shall repay any remaining
- 13 loan balance at the rate of ten per cent simple interest.
- (e) In accordance with chapter 103D, the university shall
- 15 enter into written contracts with collection agencies for the
- 16 purpose of collecting delinquent student loans. All payments
- 17 collected by a collection agency, including late fees and all
- 18 other reasonable costs, exclusive of the collection agency's
- 19 commissions, shall revert and be credited to the Hawaii medical
- 20 doctor loan program revolving fund. A collection agency that
- 21 enters into a written contract with the university for the
- 22 collection of delinquent student loans, pursuant to this

- 1 section, shall collect a commission from the debtor in
- 2 accordance with the terms of, and up to the amounts authorized
- 3 in, the written contract.
- 4 (f) Liability for repayment of a loan shall be canceled
- 5 upon the death or permanent total disability of the loan
- 6 recipient.
- 7 §304A-C Capacity of minors in qualifying for Hawaii
- 8 medical doctor loans. Any student otherwise qualifying for a
- 9 loan under the Hawaii medical doctor loan program shall not be
- 10 disqualified because the student is under the age of eighteen
- 11 years, and for the purpose of applying for, receiving, and
- 12 repaying the loan, the student shall be deemed to have full
- 13 legal capacity to act and shall have all rights, powers,
- 14 privileges, and obligations of an adult with respect to the
- 15 loan.
- 16 §304A-D Rules governing Hawaii medical doctor loan
- 17 program. The university may adopt rules to implement the Hawaii
- 18 medical doctor loan program. The rules shall be adopted
- 19 pursuant to chapter 91 but shall be exempt from the public
- 20 notice and public hearing requirements."

1 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is 2 amended by adding a new section to part V to be appropriately 3 designated and to read as follows: 4 Hawaii medical doctor loan program revolving "§304A-5 fund. There is established a revolving fund to be known as the 6 Hawaii medical doctor loan program revolving fund. The fund 7 shall be a revolving fund and all interest and payments received 8 on account of principal shall be credited to the fund. The fund 9 shall be administered by the board of regents and shall be 10 disbursed to qualified students who meet eligibility 11 requirements under section 304A-A pursuant to rules adopted by 12 the board." 13 SECTION 3. There is appropriated out of the general 14 revenues of the State of Hawaii the sum of \$ 15 much thereof as may be necessary for fiscal year 2011-2012 and 16 the same sum or so much thereof as may be necessary for fiscal 17 year 2012-2013 for deposit into the Hawaii medical doctor loan 18 program revolving fund established by this Act. 19 SECTION 4. There is appropriated out of the Hawaii medical 20 doctor loan program revolving fund the sum of \$ or so 21 much thereof as may be necessary for fiscal year 2011-2012 and 22 the same sum or so much thereof as may be necessary for fiscal

- 1 year 2012-2013 for deposit into the Hawaii medical doctor loan
- 2 program revolving fund established by this Act.
- 3 The sums appropriated shall be expended by the University
- 4 of Hawaii for the purposes of this Act.
- 5 SECTION 5. In codifying the new sections added by section
- 6 1 of this Act, the revisor of statutes shall substitute
- 7 appropriate section numbers for the letters used in designating
- 8 the new sections in this Act.
- 9 SECTION 6. New statutory material is underscored.
- 10 SECTION 7. This Act shall take effect on July 1, 2050.
