A BILL FOR AN ACT

RELATING TO HAWAII GRANT OFFICE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that competing for
- 2 federal grant moneys is critical to the funding of numerous
- 3 programs and that having shared expertise available for state
- 4 employees will help identify and successfully apply for grants.
- 5 The legislature further finds that a Hawaii grant office is
- 6 necessary to serve as a central source of expertise for all of
- 7 the procedures involved in the grant application process,
- 8 including education, training, identifying available grants, and
- 9 grant writing. State applications for grants are decentralized,
- 10 yet consist of many common elements and processes. In-house
- 11 agency grant expertise can be improved upon, using the state
- 12 procurement office as a model.
- 13 This Act provides a structure within the University of
- 14 Hawaii for a Hawaii grant office that supports state agencies in
- 15 the pursuit of grant and subsidy funding.
- 16 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is
- amended by adding a new subpart to part IV to be appropriately
- 18 designated and to read as follows:

1 Hawaii Grant Office 2 §304A-A Hawaii grant office; established. (a) 3 shall be a Hawaii grant office, within the University of Hawaii. 4 The Hawaii grant office shall be administered by a chief grant 5 officer to be appointed by the governor. 6 The mission of the Hawaii grant office is to support 7 state agencies in the pursuit of grant and subsidy funding. 8 (c) Nothing in this subpart or rules adopted hereunder shall prevent or hinder any agency from applying for, receiving, 9 10 or using federal funds; complying with the terms or conditions 11 of any grant, bequest, or subsidy; or from satisfying any 12 requirement of a federal statute or regulation to avoid the loss or reduction of federal assistance. 13 §304A-B Definitions. As used in this subpart, unless the 14 15 context clearly requires otherwise: 16 "Agency" means any department, authority, commission, council, board, committee, institution, legislative body, 17 18 agency, or other establishment or office of the executive, 19 legislative, or judicial branch of the State, including the 20 office of Hawaiian affairs. 21 "Grant" means the furnishing of assistance, whether 22 financial or otherwise, to any recipient to support a program

16		efforts, lessons learned, and recommendations by the
17		grant office.

19	There is	created an autonomous state grant policy board.
20	(b)	The policy board shall consist of nine members.

2	(2)	Two county employees with significant high-level grant
3		experience; and
4	(3)	Six persons, including a grant professional, two
5		members with significant high-level federal grant
6		experience, and two members with significant
7		experience in the fields of education, health, or
8		human services.
9	(c)	Each appointed member of the policy board shall have
10	demonstra	ted sufficient business or professional experience to
11	discharge	the functions of the policy board. Other than the
12	comptrolle	er, the members of the policy board shall be appointed
13	by the go	vernor from a list of three individuals for each vacant
14	position,	to be submitted by a nominating committee. The
15	nominatin	g committee shall be composed of the following four
16	individua	ls:
17	(1)	Two members appointed by the governor;
18	(2)	One member appointed by the president of the senate;
19		and
20	(3)	One member appointed by the speaker of the house of
21		representatives.

- 1 Except as provided in this section, the selection and terms of
- 2 the policy board members shall be subject to the requirements of
- 3 section 26-34. The members of the policy board shall devote
- 4 sufficient time to their duties as may be necessary for the
- 5 proper discharge thereof.
- 6 (d) The policy board shall be assisted by employees of the
- 7 department of accounting and general services, which shall
- 8 provide at least one full-time support staff and funding
- 9 necessary to support the policy board.
- (e) Members of the policy board shall be reimbursed for
- 11 any expenses, including travel expenses, reasonably incurred in
- 12 the performance of their duties.
- 13 (f) The chairperson of the policy board shall be elected
- 14 annually by a majority of its members from among all of its
- 15 members.
- 16 §304A-E Authority and duties of the grant policy board.
- 17 Except as otherwise provided in this chapter, the policy board
- 18 shall have the authority and responsibility to adopt rules,
- 19 consistent with this chapter, governing the facilitation of
- 20 grants and subsidies. All rules shall be adopted in accordance
- 21 with chapter 91; provided that the policy board may issue
- 22 interim rules by procurement directives, which shall be exempt



- 1 from the public notice, public hearing, and gubernatorial
- 2 approval requirements of chapter 91. The interim rules shall be
- 3 effective for not more than eighteen months. The policy board
- 4 shall consider and decide matters of policy within the scope of
- 5 this subpart including those referred to it by the chief grant
- 6 officer. The policy board shall have the power to audit and
- 7 monitor the implementation of its rules and the requirements of
- 8 this subpart, but shall not exercise authority over the award or
- 9 administration of any particular grant or subsidy, or over any
- 10 dispute, claim, or litigation pertaining thereto.
- 11 §304A-F Grant advisory groups. (a) The chief grant
- 12 officer may appoint grant advisory groups to assist in specific
- 13 areas and any other matter that the chief grant officer deems
- 14 necessary.
- (b) Members of grant advisory groups may be reimbursed for
- 16 expenses incurred in the performance of their duties, subject to
- 17 such expenditure limitations prescribed by the policy board and
- 18 applicable law.
- 19 §304A-G Interagency collaboration. Agency participation
- 20 in grant office efforts to plan, coordinate, advise, train, and
- 21 assist in the grant process, including the sharing of
- 22 information on community needs, best practices, and available



- 1 resources, shall be encouraged. Agency officers and employees
- 2 shall cooperate with the grant office and furnish to them
- 3 appropriate resources and information related to grant and
- 4 subsidy activities as may be called for in connection with the
- 5 duties of the grant office. The information shall be provided
- 6 in a timely manner and shall be free of charge."
- 7 SECTION 3. In codifying the new sections added by section
- 8 2 of this Act, the revisor of statutes shall substitute
- 9 appropriate section numbers for the letters used in designating
- 10 the new sections in this Act.
- 11 SECTION 4. This Act shall take effect upon its approval.
